**Re: The Nunavut Impact Review Board's 2024-2025 Annual Monitoring Report for Doris North Gold Mine and Phase 2 Hope Bay Belt Projects and Board Recommendations**

Dear Colleen Prather:

The Nunavut Impact Review Board (NIRB or Board) is hereby releasing its 2024-2025 Annual Monitoring Report for Agnico Eagle Mine Limited's Doris North Gold Mine (NIRB File No. 05MN047) and Phase 2 Hope Bay Belt (NIRB File No. 12MN001) Projects along with the NIRB's assessment of Agnico Eagle Mines Limited's (Agnico Eagle) Compliance Status with both the Doris North Gold Mine Project Certificate No. 003, Amendment 02 and the Phase 2 Hope Bay Belt Project Certificate No. 009<sup>1</sup>. This report provides the findings that resulted from the monitoring of Doris North Gold Mine and Phase 2 Hope Bay Belt Projects from October 2024 to September 2025.

## RECOMMENDATIONS

In regard to the annual reporting, the NIRB notes that the volume of material submitted in the annual report submitted for other projects is increasing year by year, and should operations resume at Hope Bay this is expected to also happen with this project. Much of this information is reporting that is required to be submitted to regulatory authorities and creates redundancy that may be unnecessary. The NIRB will be discussing this issue with Agnico Eagle and other parties.

According to Project Certificate 009, section 4.1<sup>2</sup>, the NIRB notes that establishing an online location for non-confidential monitoring and reporting documents would help address issues related to the volume and redundancy of material submitted to the Board. While Agnico Eagle does currently have a website for the Annual Reports submitted to the NIRB and NWB, it does not provide the breadth of information contemplated in the Project Certificate.

**Recommendation 1:** Agnico Eagle shall provide an update within 30 days of receiving the NIRB Monitoring Officers' 2025 Report, on the development of a publicly-accessible Project-specific web portal or web page to make available in a central location all significant non-confidential monitoring and reporting information submitted to Regulatory Authorities pursuant to the Project Certificate and other territorial or federal permits issued for the Project.

**Recommendation 2:** Agnico Eagle shall have a publicly-accessible Project-specific web portal or web page to make available in a central location all significant non-confidential monitoring and reporting information submitted to Regulatory Authorities pursuant to the Project Certificate and other territorial or federal permits issued for the Project in place for the 2026-2027 reporting year.
