**RE: Comment Request for Potential 12.4.3 Exemption to Rescan's Amendment Request  
"2012 Hope Bay Belt Environmental Baseline Program" project proposal**

Environment Canada (EC) has reviewed the information submitted to the Nunavut Impact Review Board (NIRB) regarding the above-mentioned potential exemption. The following specialist advice has been provided pursuant to the *Canadian Environmental Protection Act*, Section 36(3) of the *Fisheries Act*, the *Migratory Birds Convention Act*, and the *Species at Risk Act*.

Rescan is proposing the installation of a 60 m high wind tower in the study area to monitor wind and potential wind resources on site as an addition to their previously screened activities related environmental baseline studies in the Hope Bay Region.

Tall structures such as wind towers can pose a collision hazard for migratory birds, especially during periods of low visibility. EC requests that the proponent provide additional details on the dimension of the wind tower rotor blades, tower lighting and whether the tower will be freestanding or supported by guy wires.

EC recommends the proponent consult the following documents for further information on potential impacts, risk categories, mitigation, and monitoring measures for wind towers and tall structures:
