Appendix 1: Community Engagement and Consultation Log

1. Introduction and Background

This report is being submitted as required under the Terms and Conditions of Permit to Use Commissioner's Land # LUP-06-600-022 (the Permit).

The Naujaat Diamond Project (the Project) is located 9 km northeast of the Hamlet of Naujaat, Nunavut. Since diamonds were discovered in the area in 2002, the property has undergone several phases of exploration using airborne geophysics, together with property wide till sampling, drilling, and bulk sampling. The Project is currently being evaluated by North Arrow Minerals Inc. (North Arrow or the Company) and consists of seven mining leases and five mineral claims covering 12,705 hectares.

A total of eight kimberlite pipes have been identified within the Project, as well as several associated kimberlite dykes. The Q1-4 kimberlite (Q1-4) is the largest and most diamondiferous of the kimberlites discovered to date and has been the focus of North Arrow's work since acquiring the Project from Stornoway Diamond Corporation in 2013. The kimberlite is located on Commissioner's Land within the Municipality of Naujaat, approximately nine kilometres northeast of the community. North Arrow continues to assess Q1-4's size and diamond value potential as the Company works towards a Preliminary Economic Assessment for the Project.

In 2014 North Arrow extracted a 1,353-tonne sample from the A28 portion of the kimberlite under license LUP06-607-14. The following year, the Company submitted amendments to the permit for drilling, fuel storage and construction of a core logging facility at its storage location. Following review by GN-C&GS, GN-DoE, ECCC and NIRB, these permissions were combined and granted under permit LUP06-607-014 on May 4th, 2016.

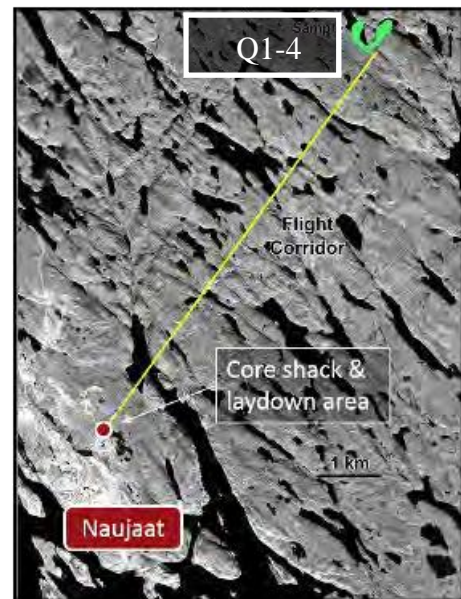


Figure 2: Flight Corridor of Helicopter from Q1- 4 to Core Shack and Laydown Area.

Permit LUP06-607-014 was renewed in 2017 and reissued as LUP06-607-~~016~~. It authorized up to 20,000 metres of drilling, and it also allowed for bulk sampling activities with a cumulative total of 1,500 tonnes. The permit was again extended in May 2021 and reissued as LUP06-607-017. It maintained the same terms and conditions, and also allowed for an increase of 500 tonnes to the total cumulative bulk sample weight, increasing the total allowable tonnage to 2,000 tonnes.

Under LUP06-607-017 North Arrow conducted a summer exploration program in 2021 that ran from June 17th to August 23rd. Fieldwork consisted primarily of bulk sampling at the Q1-4 kimberlite, and a small amount of till sampling and prospecting was also completed. Exploration crews were based in Naujaat, and a helicopter was used for transporting sample bags and work crew between town and the work site, approximately 9 km away.

A new permit (LUP06-600-022) was belatedly issued by CGS on June 6, 2024 to cover the period of September 1, 2023 to August 31, 2025.

A wildlife camera monitoring program had been conducted in cooperation with the Arviq Hunters and Trappers Organization (HTO) in Naujaat between May 2017 and April 2021. The wildlife cameras were collecting baseline information between Naujaat and the Q1-4 diamond deposit along the alignment of an existing ATV trail that was being considered for an upgrade to an all-season Community Access Road. The cameras were taken down at the request of the Hamlet's Wildlife Officer in 2021 who had recently been made aware that a permit was required to set out the cameras. The Hamlet has stated they will consider acquiring a "Wildlife Research Permit" if the Community Access Trail Project becomes revitalized.

2. Regulatory Information

Exploration work on the Project is conducted under the terms and conditions of land use authorizations granted by the Government of Nunavut (GN) Department of Community and Government Services (CGS), and by the Nunavut Water Board (NWB). As part of the permitting process, the Project permit applications are screened by the Nunavut Planning Commission (NPC) and Nunavut Impact Review Board (NIRB) prior to issuance by the authorizing agencies. The following permits, licenses and file numbers are associated with work conducted at the Naujaat Diamond Project:

CGS: Municipal Land Use Permit LUP-06-600-022; expires Aug. 31st, 2025 (Extension pending)

NWB: License 2BE-QIL2328 Type "B"; expires Apr. 1st, 2028.

NPC: File No. 148542 (Naujaat Q1-4 Project); conformity determination issued Feb. 27th, 2015.

NIRB: File No. 12EN012; Screening Decision Report dated June 5th, 2015.

3. Laydown and Core Storage Area

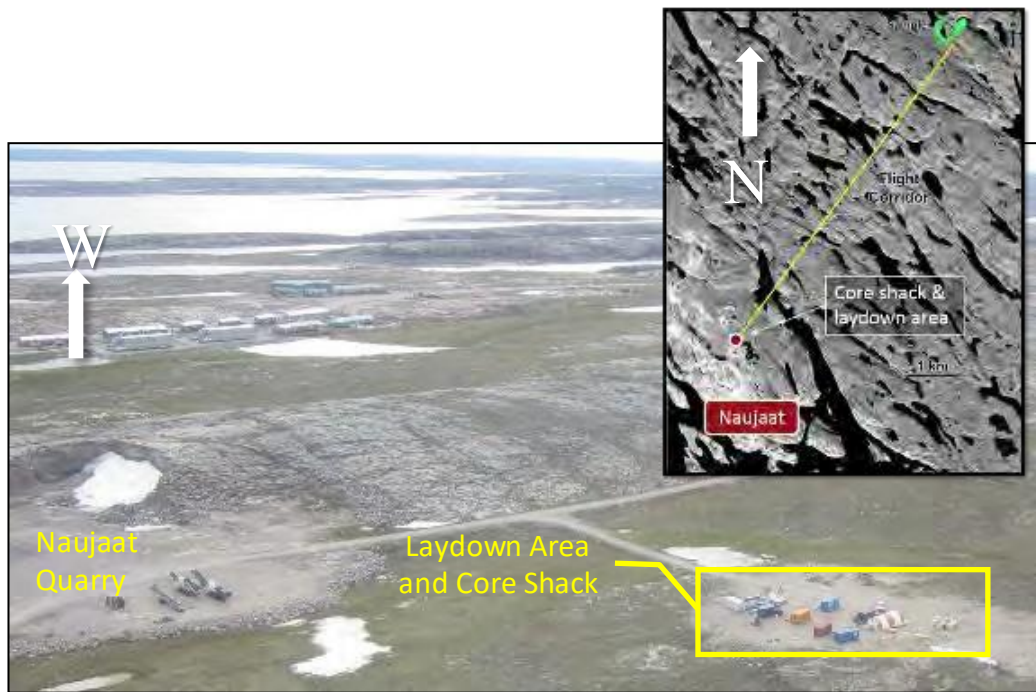


Figure 3 (Inset): satellite image of Naujaat relative to Q1-4 kimberlite and Core Shack/Laydown Area. **(Main Image):** view looking west above Laydown Area and town quarry (August 2017).

A small equipment and core storage area was established approximately 1 km north of the town as part of permitted activities going back to 2014 (Figure 3). This facility continues to be utilized and is regularly monitored by a local employee to ensure the security and integrity of equipment and materials is maintained.

A moderate supply of drummed aviation fuel (JetA) is also stored at the laydown area. Drummed fuel is stored in large secondary containment berms (Figure 4), and drums are regularly checked for damage and leaks by a local employee. No leaks were reported in 2024.

4. 2024 Project Activities

No work was conducted at the project in 2024. A downturn in the diamond sector due to the impact of lab grown diamonds and other factors, has affected the ability of North Arrow to raise money for any diamond exploration related work for the time being. The company awaits a turnaround in the market so money can be raised to continue Naujaat Project work.

In anticipation of a turnaround, North Arrow continues to keep the Project permitted for drilling and sampling under permit LUP06-600-022. Permit LUP06-600-022 includes authorization for a 'laydown area and core storage area' near the town quarry where fuel, equipment and supplies are kept. The Company continues to use a local employee to maintain and keep secure the laydown area even while no work is happening at the deposit site.

Some of the drilling equipment is also stored out

at the Q1-4 deposit site. The local employee responsible for the integrity of the laydown area also checks on the drill and related equipment at the Q1-4 deposit site from time to time when out on the land to ensure they are tidy, intact and secure. See images below:

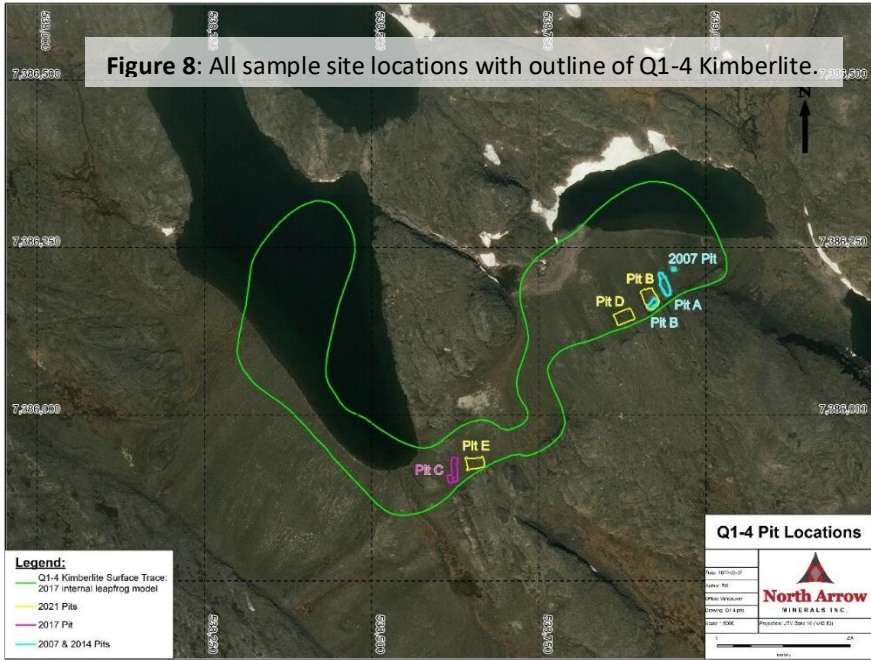


Figure 8: All sample site locations with outline of Q1-4 Kimberlite.

The last major work program conducted at the site was in 2021. North Arrow conducted bulk sampling at the Naujaat Diamond Project from three sites at the Q1-4 kimberlite (Figure 8).

Once sample collection was complete, two mini excavators remained at site for pit reclamation. A site visit was organized for August 18th, 2021, allowing two Hamlet councilors to inspect the reclaimed sample pits and the surrounding work area. No concerns were raised by either councilor. Following reclamation, the two excavators were slung back to the laydown area in town and loaded into shipping containers for winter storage, which is where they remain currently.

Staff investigated the 2021 sample pits from the ground during community meetings in summer 2022 and found no significant changes to the landscape (Figures 10-12, and 15). A local employee continues to check on the reclamation work when in the area and send photos back to North Arrow's head office in Vancouver (see Figure 15).

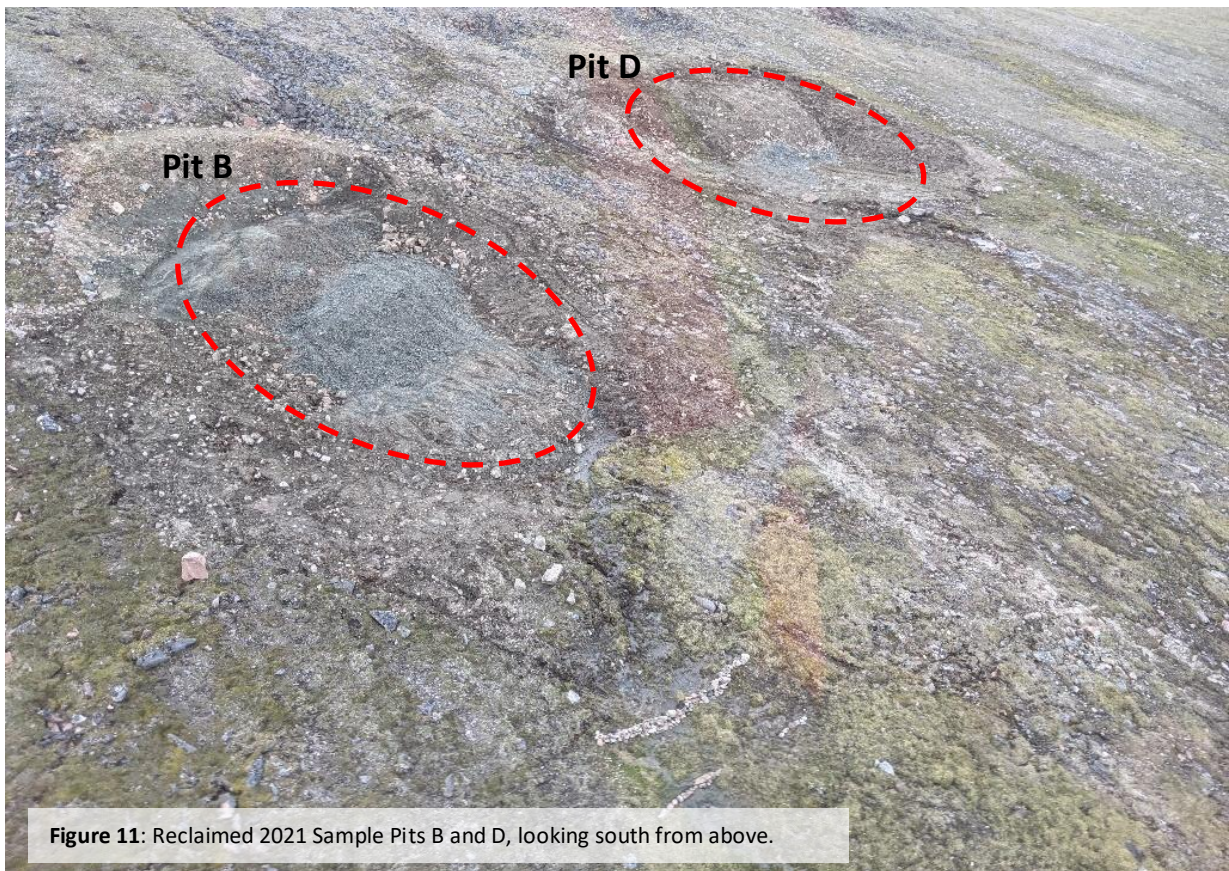


Figure 11: Reclaimed 2021 Sample Pits B and D, looking south from above.

5. Personnel

One local employee was hired on a part-time basis to maintain North Arrow's laydown facility, visiting the site Mondays, Wednesdays and Fridays to ensure the area was secure and undamaged by weather or vandalism.

Nothing of significance (i.e. fuel spills, garbage, break-ins/damage, etc.) was reported during checks at the laydown area in 2024.

6. Wildlife Monitoring

Wildlife monitoring was not conducted in 2024 as there was no work done.

7. Community Engagement and Consultation

Even though no exploration work happened at the Naujaat Project in 2024, North Arrow continued to engage with the Hamlet's leadership, the HTO, and the MLA for Aivilik who is from Naujaat.

A letter of congratulations was emailed to new Mayor, Kevin Tegumiar in February 2024 and an update on the Naujaat Project was provided within the letter.

Mayor Tegumiar responded in September of 2024 that the Council is hoping to re-establish the Mining and Exploration Advisory Committee (North Arrow met with them in person in 2022 – see below) and invited North Arrow to reach out to the group with any Naujaat Project developments in the form of a newsletter, a Zoom Meeting or an in-person meeting if funding is available. North

Arrow plans to follow up on the invitation in the coming months once we receive communication from our joint venture partner on the project, Burgundy Diamond Mines.

North Arrow last visited the community in summer 2022. The trip occurred during the week of July 17th, and North Arrow remained in the community for approximately one week for various engagements. Formal meetings were held with the Hamlet Council and Mayor, the Arviq HTO, a newly formed Mining and Exploration Advisory Committee, MLA Solomon Malliki, and the greater community. Detailed logs are included in Appendix 1.

At each meeting, a presentation was given on the Naujaat Project, followed by discussion and a question-and-answer period which was recorded and documented. Most post-presentation discussions were spent on matters that included permitting, financing, environmental impact, future employment opportunities, training, a Hamlet-proposed community access trail, and Burgundy Diamond Mines, North Arrow's joint venture partner on the project.

Points of discussion regarding the project:

- Number and type of jobs that would be created if a mine were to be built
- If and when a mine might be built
- Impacts and benefits if a mine was to be built
- Project timing
- Who will be the company running a potential future mine, if not North Arrow
- Helicopters
- Sample shipment and processing
- Community access trail
- Number, size, colour and value of diamonds produced from the 2021 bulk sample
- Care for the environment

8. Summary and Future Work

Permit LUP-06-600-022 was issued on June 6th, 2024. The new permit covers the time-period September 1st, 2023, to August 31st, 2025, and has the same Terms and Conditions applied to the previous permits, authorizing bulk sampling, drilling, fuel storage, and a core logging facility at North Arrow's laydown facility.

No work was conducted in 2024 but a local employee continued to visit the laydown site three times per week to ensure it was secure and well-maintained.

Future Work

A permit renewal application was submitted to the GN-CGS on November 21st, 2024, and was forwarded to the Hamlet Council by Randy Mercer (Regional Manager, Lands Administration). A two-year permit extension was approved by Hamlet Council on February 4th, 2025. Final issuance of the permit by CGS is pending.

The Q1-4 deposit includes a small, but predictable population of high-value, yellow-orange coloured diamonds. They are of coarse-grained size but have variable clarity thus far. From what

is known about the value of the finer (or “less coarse”) white diamond population, for the deposit to be economic, a high \$/carat value for the coloured diamonds will be required. To determine the value of the coloured diamonds a bulk sample an order of magnitude larger than the one collected in 2021 (i.e. 10,000 tonnes) will be required so that clear and coloured diamonds may be found in the larger sizes and a more accurate value for the diamonds can be determined.

This value could then be used as one variable of the economic equation that will make up a Preliminary Economic Assessment. Further work will also be required to fully delineate the kimberlite to estimate total tonnage down to 300 m. for the Q1-4 kimberlite. This may be done through different categories of work and is likely to include a combination of delineation drilling, and geophysics. Unfortunately, interest in funding diamond exploration projects has dried up for the time being due to a drop in diamond prices from the impact of lab-grown diamonds, as well as other factors, and there are currently no set plans for work in 2025 at the project.
