Re: Opportunity to Address Comments Received Regarding Baffinland Iron Mine Corporation's "Mary River Project 2017 Annual Monitoring Report"

Dear Megan Lord-Hoyle:

On April 4, 2018 the Nunavut Impact Review Board (NIRB or Board) received Baffinland Iron Mine Corporation's (Baffinland or Proponent) *Mary River Project 2017 Annual Monitoring* (the Annual Report). As per section 12.7 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada* (Nunavut Agreement) and the amended Mary River Project Certificate [No. 005], the NIRB's monitoring program focuses on compliance and effects monitoring as related to the Mary River Project (NIRB File No. 08MN053).

On April 6, 2018 the NIRB requested that interested parties review the Annual Report and provide comments with respect to their jurisdiction and/or area of expertise on whether the conclusions reached by Baffinland in the Annual Report were valid. Furthermore, parties were requested to comment on Baffinland's compliance status with regard to authorizations that have been issued for the Project Certificate. On or before May 15, 2018 the NIRB received comments from the following interested parties:

- Government of Nunavut (GN)
- Environment and Climate Change Canada (ECCC)
- Fisheries and Oceans Canada (DFO)
