 - o Recommended terms and conditions for the Itivia Quarry project, if necessary referencing the conditions in relation to the quarry's linkage to the Meliadine Gold Mine Project and possible interplay with the terms and conditions of Project Certificate No. 006, or if not sufficient to address the Party's concerns, justification to amend the Meliadine Gold Mine Project Certificate.
