May 23-mi, 2017-mi taapkua Nunavunmi Avatiliriryuakkut Katimayit (NIRB-kut imaaluuniit Katimayit) tuniyauhimayut ihivriuqtaghainik taapkuninnga ArcticNet’p “ArcticNet Havaariyauyukhanut 1: Una Qulvahiktuq Uataa Ikaaruhik kinguangani haffumani Kingulliqpaaq Hirmik Auktuyuittuq. ArcticNet 2: Kuugaq ihivriughiyut uvani 2017 ArcticNet qauviharningit” umiaqtuqtughat tughirautainik talvanngat Nunavunmi Parnaiyaiyit (NPC-kut imaaluuniit Kamissingat) iliqahiutihimaplugu taamna titiraq malittiaqniaqhimayuriplutik taapkuninnga Tununngaani Qikiqtaaluk Aviktuqhimayumi Nunanik Atutittiniqmut Parnaiyautainik. Una NPC naunaiqhiiyut hamna hivunngani malittiarnikhanut hivunikhaliurutikhanut qaangiqtahimayug uvani July 11, 2006 mi hulidjuhikhainut ilagiyauyuq atuhimayangit tukhirautaanut huli aturnaqtug hivunikhaliuqhimayug hamna havaariyakhaat tukhirautaa hivituyumik ihuaqhiyauyuq havaariyakhanut ilagiyauhimangmat haffumani kititiqhimaningit kuukkanut naunaiqhiiyangit ilagiyauunnginnami haffumani nanmiriyauyunit kinguaniluuniit aallannguqtirutaanit uumani tukhirutaanut ilaliutigiyangit hivituyug ihuaqhainikhanut haffumani havaariyauyukhanut.

Malikhimayangit uumani Nakataq 12, Ilangani 12.4.1 unalu 12.4.4 haffumani *Angirunmi uumani Inuinnaik haffumani Nunavut Nunataarviup Iluani unalu Kanataup Kavamanga Kivgaqtuiyuq Kuinmik* (Nunavut

Angirutaata) unalu ilangani 87 haffumani *Nunavut Upalungaiyaiyut Qauyiharnirnut Maligaq* (NuPPAA), una NIRB nakuutqiyahiuqaaqhutik uumani havaariyakhanut tukhirutaanit. Taamna tukhirutauyuq huliyaqhaqahutik taamna nalaumattiaqtumik ilagiyauvlutik uvunga ihivriuqtauhimagaluaqtut huliyaqhait malikhugu NIRB titiqqaitigut nampalik **06YN071**, una NIRB ihivriuqhimayaraluangit havaariyakhat tukhiutirutaanit ihuaqhiyauvluni aallannguqtiqhugu uvunga nakuutqiyahiuqtunut havaangit nuutkaqtitauvluni una tukhirutaanit uumani titiqqaitigut nampagaluangit.

Malikhugit tahapkuninga tutkikhakhikhimayunik tamakpianginik atugakhanik tukihigiarutinik hunnaikhimayunik, tahapkuat NIRB pitkuihimayut talvuna utiutifaakpaktunik ArcticNet’p “ArcticNet Havaariyauyukhanut 1: Una Qulvahiktuq Uataa Ikaaruhig kinguangani haffumani Kingulliqaq Hirmik Auktuyuittuq. ArcticNet 2: Kuugaq ihivriuqhiyut uvani 2017 ArcticNet qauyiharningit” havaakhautikhanik” atuktaulimaituk aullaktikgutikhanik talvuna makpiranginik 92(1)(a) talvuna NuPPAA.

Malikhugu piyumayangit ataaniittuq titiraqhimayumi 92(2)(a) haffumani NuPPAA, hamna NIRB ihumaliuqhimayangit taihiniit qanurilinganingiillu nalaumattiaquvlugit havaariyauyukhanut.

Hamna Ihivriuqniqmut Ihumaliurniq Taiguagakhaq ilaqaqhuni, tamainnut aahiittauq, maliguarutit havaariyauyukhait, havaariyangit tamatkiumayangit hamnalun NIRB qauyiharningit piliriakhait, ilaliutilluaqhugillu nalaumayumik qanuq ihumaliuriangani aktuqtaulluarningit kiugiaqaqtuniglu havaariyanut hivituningit qanurilingayauningillu.
