On June 8, 2017, the Nunavut Impact Review Board (NIRB FILE NO. 17YN016) terminated the assessment of the previous project proposal pursuant to Subsection 143(6) of the Nunavut Planning and Project Assessment Act (NUPPAA). The current project proposal requires screening by the Nunavut Impact Review Board (NIRB) because it does not belong to a class of exempt works or activities set out in Schedule 12-1 of the Nunavut Agreement.

The regulatory authorities to which this letter is addressed are responsible under the NUPPAA to implement any of the applicable requirements by incorporating the requirements directly, or otherwise ensuring that they must be met, in the terms and conditions of any authorizations issued.

This conformity determination applies only to the above noted project proposal as submitted. Proponents may not carry out projects and regulatory authorities may not issue licenses, permits and other authorizations in respect of projects if a review by the NPC is required. Regulatory authorities may consult with the NPC to obtain recommendations on their duties to implement the existing land use plans prior to issuing licenses, permits and other authorizations under subsection 69(6) of the NUPPAA.
