This email is a follow up to the Suspension of Assessment of Activities issued by the Nunavut Impact Review Board (NIRB or Board) dated, April 10, 2019 for the Hamlet of Arviat's "Arviat Wind Energy Project" proposal (NIRB: 18UN044; NPC: 148907).

The NIRB requests that the Hamlet of Arviat provide an update to confirm whether the company expects to re-engage the assessment process for the "Arviat Wind Energy Project" proposal and if so, when can the NIRB expect the material be submitted? Please note that if such a written request has not been filed by April 10, 2022 the assessment of the project will be terminated as per section 143(4) of the *Nunavut Planning and Project Assessment Act (NuPPAA)*. You would then have to re-apply through the Nunavut Planning Commission (Commission).
