Whereas the Mittimatalik Hunters And Trappers Organization (MHTO) does not have adequate information regarding the impacts of operations at the most recently permitted GMTPA rate of mining and transportation at Baffinland Iron Mines Corporation's (Baffinland) Mary River project;

And Whereas MHTO does not have adequate information about the potential impacts of continuing Mary River operations at the proposed Sustaining Operations rate of GMTPA;

And Whereas the cumulative effects assessment for the Sustaining Operations Proposal does not adequately consider impacts to wildlife or habitat from on going operations at GMTPA since originally permitted, and continuing for an additional 2 years;

And Whereas the current monitoring programs do not provide sufficient evidence that established measures are effectively mitigating impacts at the GMTPA rate of mining and transportation at the Mary River project;

And Whereas there is no opportunity to provide final submissions after Baffinland has prepared a response and Community round table participants have provided input to the Nunavut Impact Review Board and our membership;

Now Therefore be it resolved, that the Mittimatalik Hunters And Trappers Organization: Recommends that the Nunavut Impact Review Board Reject Baffinland's application for the Sustaining Operations Proposal at this time.
