The Nunavut Planning Commission (NPC) has determined that this project proposal is outside the area of an applicable regional land use plan. The Nunavut Impact Review Board (NIRB) previously reviewed the works and activities associated with the current proposal, including wildlife viewing (NIRB FILE NO. 13AN020).

The NPC has determined that the above-noted project proposal is a significant modification to the project because of the new itinerary which intends to visit the community of Pangnirtung.

The above-noted project proposal requires screening by the NIRB under section 12.4.3 of the Nunavut Agreement as amended because it is for a component or activity that was not part of the original or previously amended proposal and its inclusion is a significant modification of the project.
