<p>Do you have any suggestions or recommendations for this application?</p> <p>The Fish and Fish Habitat Protection Program encourage all project proponents to avoid causing the death of fish and the harmful alteration, disruption or destruction of fish habitat. Based on the information provided, the proposal has been identified as a project that will not require an authorization under the <i>Fisheries Act</i> or the <i>Species at Risk Act</i>. In order to comply with fish and fish habitat provisions of the <i>Fisheries Act</i>, it is recommended that the proponent follow the measures to protect fish and fish habitat, which can be found on DFO's Projects Near Water website (https://www.dfo-mpo.gc.ca/pnw-ppe/measures-mesures-eng.html).</p>
