The following works and activities have been proposed in the above-noted project proposal:

1. Amendment to Mineral exploration program consisting of airborne and ground-based surveying, a drilling program, temporary camps, and environmental monitoring, baseline studies, and archaeological assessment.
2. Summary of proposed modifications:
 - a. Increased water use
 - b. Increased person-days
 - c. Increased fuel storage
 - d. Increased drilling
 - e. Additional licences or permits for potential baseline studies related to environmental monitoring
3. Timing, Duration, & Personnel:
 - a. Approximately 150 days over period 1 March 2025 to 1 March 2032
 - b. Approximately 20 to 25 personnel for a total of approximately 3000 to 3750 person-days
4. Associated NPC File No. 150199; Associated NIRB File No. N/A (not previously screened)
5. Location: Kitikmeot Region; [Coppermine River area west of Kugluktuk]

A complete description of the project proposal reviewed by the Nunavut Planning Commission (NPC) can be accessed online using the link below.

The NPC has completed its review of the above-noted project proposal and has determined that it is outside the area of an applicable regional land use plan. In addition, the NPC has determined that the project proposal is a significant modification to the project because of the increase in person-days at camp, increased fuel storage, and additional licences and permits.

The above-noted project proposal requires screening by the Nunavut Impact Review Board (NIRB) because it does not belong to a class of exempt works or activities set out in Schedule 12-1 of the *Nunavut Agreement*.
