**RE: NPC File No. 150257 [Bernard Harbour PIN-C Contaminated Site Remediation Project]**

The following works and activities have been proposed in the above-noted project proposal:

1. Site Cleanup / Remediation and Temporary Structures: CIRNAC plans to complete an environment site remediation project at the PIN-C, Bernard Harbour Former Intermediate Distant Early Warning (DEW) Line site, consisting of:
  - a. Mobilization and demobilization of personnel, equipment, materials, and support facilities by sealift or air
  - b. Establishment and deconstruction of a temporary camp

- c. Cleanup and remediation activities (including some treatments in situ and disposal of soils and wastes at off-site facilities)
2. Timing, Duration, & Personnel:
  - a. 119 days over period 9 September 2025 to 9 September 2026
  - b. 25 personnel for a total of 2975 person-days
3. Location: Kitikmeot Region; [Bernard Harbour Former Intermediate DEW Line site, approximately 100 km north-northeast of Kugluktuk]

The NPC has determined that this project proposal is outside the area of an applicable regional land use plan. The project proposal requires screening by the Nunavut Impact Review Board (NIRB) because it does not belong to a class of exempt works or activities set out in Schedule 12-1 of the *Nunavut Agreement*.
