RE: NPC File No. 150391 [2024 Field Research Program for the Grays Bay Road and Port Project]

The following works and activities have been proposed in the above-noted project proposal:

1. Field research program to support the development of the Grays Bay Port and Road:
 - a. Placement of wildlife observation cameras, automated recording units and related support structures between Jericho Mine and Grays Bay for wildlife and bird observation.
 - b. Collection of baseline noise data at the proposed port site using a sound level meter.
 - c. Servicing and potential replacement of existing equipment at the Grays Bay Meteorological Station.
 - d. Marine sediment, benthic community, and water sampling.

- e. Assessment of freshwater fish habitat, fish species, and bathymetric data collection at watercourses in the port area.
 - f. Vegetation (rare plant) assessments in the port area.
2. Use of existing and permitted camps and fuel caches.
3. Modifications to the amended project proposal: additional baseline studies associated with the development.

A complete description of the project proposal reviewed by the Nunavut Planning Commission (NPC) can be accessed online using the link below.

The NPC has completed its review of the above noted project proposal. The NPC previously reviewed works and activities associated with the current project proposal including collection of baseline data for a variety of parameters and a decision was issued on July 17, 2017 (NPC File No. 148610) that it is outside the area of an applicable regional land use plan. In addition, works and activities associated with the current proposal were previously screened by the Nunavut Impact Review Board (NIRB File No.: 17YN067).

The above-noted project proposal is exempt from screening by the NIRB because the NPC is of the understanding that the continuation and inclusion of additional baseline studies does not change the general scope of the previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the *Nunavut Agreement* do not apply.

By way of this letter, the NPC is forwarding the project proposal to the regulatory authorities identified by the proponent. Project materials are available at the following address:

This decision applies only to the above noted project proposal as submitted.
