**Re: Notice of Screening for Environment and Climate Change Canada's "Isachsen High Arctic Weather Station Waste Fuel Reduction Program" Project Proposal**

Dear Owen Wade:

On April 11, 2025, the NIRB received a referral to screen Environment and Climate Change Canada (ECCC)'s "Isachsen High Arctic Weather Station Waste Fuel Reduction Program" project proposal from the Nunavut Planning Commission (Commission), with an accompanying positive conformity determination with the North Baffin Regional Land Use Plan.

On April 16, 2025, the NIRB received the complete application from the Proponent and assigned it file number **25UN029** - please reference this file number in all future related correspondence.

Pursuant to Article 12, Sections 12.4.1 and 12.4.4 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement)* and section 87 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (NuPPAA), the NIRB has commenced screening this project proposal, and by copy of this letter, **invites interested parties and municipalities potentially affected by the proposal to comment directly to the Nunavut Impact Review Board.**

#### PROJECT OVERVIEW

***Project Scope:***

<b>Location:</b>	Isachsen High Arctic Weather Station on the western shore of Ellef Ringnes Island in the Swerdrup Islands, Qikiqtani region
<b>Summary of Project Description:</b>	As part of the initial step in the overall decommissioning and remediation work planned at the Isachsen High Arctic Weather Station, the Proponent intends to undertake incineration of waste fuel located at the site.
<b>Project Proposed Timeline:</b>	June 2025 to August 2025

According to the current project proposal, the scope of the project includes the following undertakings, works or activities:

- Incinerate up to 76,000 litres of waste fuel contained in storage tanks and hundreds of drums;
- Use of two (2) reconditioned forced-air incinerators to incinerate old diesel, jet fuels, kerosene and gasoline located in drums, and above ground storage tanks (AST);
- Removal of hazardous wastes off-site for proper disposal that cannot be incinerated (e.g., drums containing lead above guidelines for incineration);
- Removal of non-combustible wastes off-site for proper disposal;
- Use of fuel to preheat incinerators and refuel the Twin Otter and generators;
- Use of water from meltwater pond for camp purposes; and
- Use of seasonal work camp at the weather station.

#### ***Inclusion or Exclusion of Scoping List***

At this time, while referenced in the application, the following activities were found not to be sufficiently developed to be included within the scope and were noted by the Proponent that they would be managed during the next phase of the decommissioning activities at the site:

- Future processing and crushing of empty drums;
- Certification of ASTs as out of service;
- Removal of sludge or residual fuels from ASTs; and,
- Tank abatement and deconstruction.

As a result, the NIRB will proceed with screening the project based on the scope as described above.

The NIRB is copying parties and municipalities potentially affected by ECCC's project proposal with this letter, and we invite interested parties to comment directly to the NIRB by **May 30, 2025**.

The NIRB would like parties to provide comments regarding:

- Whether the project proposal is likely to arouse significant public concern; and if so, why;
- Whether the project proposal is likely to cause significant adverse eco-systemic or socio-economic effects; and if so, why;
- Whether the project proposal is likely to cause significant adverse impacts on wildlife habitat or Inuit harvest activities; and if so, why;
- Whether the project proposal is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (and providing any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
