Thanks for your questions and reviewing our application. Yes we'll be walking on the land (and using helicopter from Cambridge Bay to Anderson Bay). I would love to hire locals for the work, particularly as a training program for those interested in ecology/conservation, to have them in camp for some weeks each year. This year I think that could be challenging because it's just one month (mid-June to mid-July) and we'll be setting up so many new pieces as this is a new camp. But in future years, we can do it. Yes we'll have heat in our main tent (a Weatherhaven), we'll use portable propane heaters.
