## **NIRB PROJECT PROPOSAL – ARCTIC SHOREBIRD MONITORING PROGRAM**

Dear Sir or Madam:

Included is our project proposal for shorebird research in the Queen Maud Gulf Sanctuary in June-July 2005.

This project is a continuation of the studies conducted last summer on Southampton Island and Great Plains of the Koukdjuak for which we received positive NIRB reviews.

The data we are collecting will generate population estimates for breeding shorebirds across the arctic.

We have applied for a GN Wildlife Research Permit, a Sanctuary Permit from Environment Canada, an exemption permit for access to Inuit Owned Lands from the Kitikmeot Inuit Association and we have sent letters that introduce our study to the HTOs in Cambridge Bay, Umingmaktok and Gjoa Haven.
