As you're aware it became a legal requirement last year for CEAA Environmental Assessments to be conducted as part of the licencing process. With an amendment to the Nunavut land Claim that was made around June 5 of this year NIRB became the only accepted environmental assessment body for Nunavut and so it became necessary to do the NIRB assessment. We wish to thank you for your co-operation in this new process.

Parks Canada will continue to use the CEAA Environmental Assessment as a policy screening with a five year period of acceptance as long as the trips do not change and require a new screening. The NIRB Environmental Assessment is triggered by each new application and will therefore be an annual assessment.

Along with your Business Licence, Aircraft Access Permit and Guiding Permits, you will find your Environmental Assessment document and be sure to pay special attention to the mitigation

material. This mitigation material is considered part of the conditions of your business licence and your organization will need to follow these conditions when conducting business in the park

Your business licence covers the fiscal year and expires March 31, 2009.

In lieu of the guides having First Aid and CPR Certification, Guide Permits are issued conditional that the ship's doctor must accompany the expedition staff and visitors ashore in order to administer medical assistance if required.

Your aircraft access permit covers the dates August 20-21, 2008 at Tanquary Fiord.

If you need aircraft access for other groups during this fiscal year you will have to apply for an additional aircraft access permit in order to legally land with them in the park.

We wish you a successful season in Quttinirpaaq National Park.
