## RE: LAND USE PERMIT APPLICATION FOR THE FERGUSON LAKE PROJECT, STARFIELD RESOURCES INC.

Please find enclosed a completed Type B Land Use Permit application package for exploration activities at Starfield's Ferguson Lake Project. Starfield has been operating an exploration project at Ferguson Lake since 1999 on the Inuit Owned Lands. The project operated from an existing camp on an island located within Ferguson Lake until winter of 2006 when Starfield constructed a new camp, as per advice from the Kivalliq Inuit Association (KIA), on the mainland, see attached map. The camp and surrounding infrastructure operate under a commercial lease with the KIA.

Starfield currently has a water licence (NWB), 2BE-FER0712, a commercial lease (KIA), KVCL305H27, a land use licence for exploration on IOL (KIA), KVL399C150 and right of way permits to allow for overland transport to the camp from Rankin Inlet and Arviat. This project underwent a conformity screening (Nunavut Planning Commission) and was screened by the Nunavut Impact Review Board (NIRB). The most recent screenings included the amendments to move the camp location and to construct an airstrip at the camp. A copy of the screening decision from NIRB is included in this application package for your information. Starfield has been working closely with regulatory agencies and the GN wildlife biologists to develop operational standards that minimize the potential impacts to the environment, and monitoring programs that provide important and useful data which is reported annually to the regulators and is used by Starfield to improve operational management decisions. Copies of Starfield's

Environmental Management Plan and Wildlife Management Plan have been included in this application package.

All exploration activities will be based from the Ferguson Lake camp which is located on IOL and is permitted under a commercial lease with the Kivalliq Inuit Association. Crews will be transported to the field via helicopter.
