Bruce:

I searched our database for sites within 66 30N-66 40 N; 112 14W -112 24 W. There are no record archaeological sites within that area (therefore no agreement needed). However there were at least 11 newly recorded sites association with work Tahera had done in the 1990s. This means there are likely unrecorded archaeological sites within the region you would like to conduct exploration. Again as a heads up there is a very high potential that when a land use permit or IOL access permit crosses my desk from NIRB (or INAC) CLEY's recommendation will be that an archaeological inventory of the property be conducted in particular if you plan on conducting drilling. You may want to plan for this in advanced as it save headaches and holdups :-). For your information I have attached CLEY's Guidelines for Developers and a list of archaeological consultants who have worked in Nunavut in the past.
