**Re: 5050 Nunavut Ltd. 2008 Winter Trail Permit Package
for a Winter Trail from Kugluktuk to McGregor Lake Campsite.**

Franz Environmental Inc. (FRANZ) is pleased to submit this application package for access to Inuit owned land to the Kitikmeot Inuit Association (KIA) on behalf of 5050 Nunavut Ltd. 5050 Nunavut, a wholly owned subsidiary of Adriana Resources Inc. (Adriana), proposes a one-way, single-use winter trail for a Cat Train to transport equipment from Kugluktuk to their McGregor Lake campsite (approximately 100km south of Kugluktuk). The Cat Train, proposed for early February or March 2008, will consist of a Caterpillar towing a sled carrying a Bobcat and survival gear. This equipment will facilitate camp preparations and the construction of an ice airstrip in support of 5050 Nunavut's 2008 exploration activities as part of the Mackenzie Igneous Event (MIE) Project. The transit is expected to take 30hrs, weather permitting.
