### 5. a) Summary of Operation (Describe purpose, nature and location of all activities.)

The DRDC Northern Watch Technology Demonstration Project will demonstrate an Arctic maritime surveillance capability to the Department of National Defence and other concerned federal departments. This is a multi-year undertaking and is based at Gascoyne Inlet.

The surveillance demonstration system will be unmanned, semi-autonomous, and remotely controlled through a satellite system connection to one of the DRDC centres.

The existing camp will continue to be used for this project; this camp will facilitate approximately 27 persons for 28 days.

### 6. Summary of potential environmental and resource impacts

(Describe the effects of the proposed program on land, water, flora and fauna and related socio-economic areas.)

It is anticipated that this project will have little or no impact on the environment and/or resources in the area. Waste will be handled in the appropriate manner - garbage will be flown to Resolute Bay for proper disposal, sewage will be incinerated on-site, using propane powered toilets, and grey water will be screened and drained into the ground, which is loose rock/gravel. Protocols are in place to ensure that any fuel spills are contained. ATV traffic will be kept to marked trails to minimize disturbance to flora and terrain. To mitigate the danger of polar bears, bear watchers will be hired from the Resolute Bay hunters and Trappers Association and they will have the only firearms in camp.

7. Proposed Restoration Plans (Please use last page if required.)

At the conclusion of the project, all sensor, communication, and data collection equipment will be removed from the Gascoyne Inlet camp and the Cape Liddon site. The Resolute Bay hunters and Trappers will be given the choice of which buildings will remain at the Gascoyne Inlet camp - the others will be removed. The portable structures at Cape Liddon will be removed.

Fuel drums will be stored in a bermed area that has a liner install beneath a layer of aggregate. There is and will continue to be a comprehensive spill kit on-site; all staff on-site will undergo thorough spill response training. Please see attached Spill Contingency Plan.

Fuel will be transferred directly from the storage tanks to vehicles/equipment using hand pumps.

The main component to this project is to demonstrate an Arctic maritime surveillance capability; this demonstration is scheduled for Aug 2015. The Gascoyne Inlet camp will receive a minimum of annual summer maintenance visits by DRDC Atlantic staff after 2015.


