This request is to renew the land use permit N2010C0002 to continue to have the right to undertake exploration work on the claim PB1. Exploration activities would consist of geophysical surveys (terrestrial or aerial), prospecting, till sampling and diamond drilling.

To minimize impacts on soil, AEM is proposing to use heavy machinery on the tundra only during winter when there is a sufficient snow cover. If work has to be conducted during the summer, transportation would be done with an helicopter, so impacts would be only located at the drilling site.

Socio-economic impact: Exploration activities can lead to mine-life extension for the Meliadine project including general socio-economic opportunities in the Kivalliq region. In 2013, to support Meliadine's activities, an average of 12 Inuits was working on the site.




