The NIRB is aware of AANDC, GN-CGS and the NWB's authority to regulate the terms and conditions attached to the enclosed Screening Decision Report, and requests that AANDC, GN-CGS and the NWB's send a hardcopy of the authorization with NIRB's file number referenced on the document to the NIRB office to complete our files.
