**Re: Tundra Copper Corp – Letter of Support to Wildlife and
Environmental Mitigation Plan – Coppermine Project, Kitikmeot Region**

On behalf of the Kugluktuk Angoniatit Association, Hunters & Trappers Organization (HTO), Board of Directors, and after a face-to-face third meeting with Tundra Copper Corp representatives, Denise A. Lockett of Lockett Consultation Services Inc., and Zack Flood, Geologist, and after a review of the Draft V2 – Wildlife and Environmental Mitigation Plan on the Coppermine Project, this is a letter in support of the plan by the HTO board members.

On May 27, 2015, and a third meeting with Tundra Copper Corp and with representatives, Denise Lockett and Zack Flood, the Wildlife and Environmental Mitigation Plan (May 2015 – DRAFT V2) was presented for review. The draft was to follow-up with all recommendations made by the HTO board from the previous meeting(s) and how these recommendations would be met.

The major concern that was discussed was the proposed drilling program during the cow and calving activity which is in and around mid-June and normally up to fifteen days (calving and post-calving).

Recommendations made by the HTO from the previous meeting(s) and now includes the Tundra Copper Corp wildlife and mitigation plans:

1. HTO - If the program gets accepted, to move the drilling program start date to the month of July.
TUNDRA – Exploration program has been rescheduled to cause no disruption to the Bluenose East caribou herd during the calving season and migration of the cows/calves to July 5 – 15 camp construction and July 15 – September 30 geological activity and drilling.

2. HTO - To stop all activity if the site is active with animals migrating through or are present, to increase the STOP ACTIVITY AND NO DRILL PROGRAM from 1 km to a more comfortable distance.
TUNDRA - Buffers were created to cease any exploration activity near den sites as follows; wolves - 800 metres, grizzly bear 2 kilometres, wolverine 1 kilometre, fox 150 metres.
3. HTO - To STOP ACTIVITY during the cow and calving activity which normally starts in mid-June and for up to fifteen days (calving and post-calving).
TUNDRA - The camp construction and drilling program is rescheduled to avoid any impact on the caribou migrating through the site(s). To minimize negative impacts by avoiding work during the calving period and post-calving period, and to avoid disruption of the aerial survey schedule for June 2 to 10, 2015. Any work will cease until animals have moved up to 2 kilometres of the site.
4. HTO - To find out the animal density in the area before any drilling starts.
TUNDRA - Will conduct a wildlife data collection to identify wildlife species and critical habits in the area and caribou activity of the identified camp and drill site before any construction starts by GPS marking and using local hire(s) who are experienced with the animals in the area. Species listed are; Bluenose East Caribou herd, moose, muskox, arctic fox (and dens), wolf (and dens), grizzly bear (and dens), wolverine (and dens), geese (and nests), waterfowl and other water birds (and nests), ptarmigan (and nests), owls (and nests), peregrine falcons (and nests), other falcons (and nests), and fish (and other aquatic life).
5. HTO - To hire local from Kugluktuk to assist in monitoring the drill sites.
TUNDRA - Will hire local wildlife monitor(s)/surveyor to collect wildlife data of the construction and drill site before any activity starts and to continue to have monitors during the construction and drill program.
6. HTO - To hire wildlife monitors, to hire environmental monitors.
TUNDRA - Will hire from Kugluktuk to assist in monitoring the construction and drill site for wildlife activity and to monitor the environmental impacts. Will also hire carpenters during the construction period.
7. HTO - To take before and after photos of the work sites.
TUNDRA - Before any activity starts, to photograph the site and to include animal sightings, den sites, nesting sites. And to continue to take photos during the construction period and drilling period. To take photos of the take-down period and when camp activity has ceased. To photograph the site after everything the program has ceased.
8. HTO ADDITIONAL REQUESTS - That Tundra Copper Corp submits a wildlife activity report of the site and as well to continually submit wildlife activity/sightings report.


To conduct a traditional knowledge program after wildlife and environmental data has been collected as well the archeological data.

To conclude, the Kugluktuk Angoniatit Association, Hunters & Trappers Organization (HTO), accepted and supports the Wildlife and Environmental Mitigation Plan, Coppermine Project (May 2015-DRAFT V2) presented by Tundra Copper Corp. The Kugluktuk HTO will continue to support the program long as Tundra Copper Corp continues to follow the guidelines and recommendations given by the Kugluktuk HTO, and Tundra Copper Corp reports back to the Kugluktuk HTO after each activity.

Tundra Copper Corp is showing the initiative to continue to work very closely with the Kugluktuk HTO (and other Kugluktuk agencies) and has and is taking the proper steps to work together to create a working wildlife and environmental plan with minimal impact. To make the work plan, the construction site plan and drill plan, as safe, as risk free as possible, with minimal animal harassment, especially with the bluenose east caribou herd during the calving season and post-calving. To start the drill program only after the calving and cow and calf movement has minimized.

The Kugluktuk HTO is willing to work with Tundra Copper Corp, now and for the future. On behalf of the Kugluktuk Angoniatit Association, good luck with the program!
