OPERATION NUNALIVUT 2016 (NU 16) will involve up to 225 Canadian Army personnel from the Regular, Reserve Forces and Canadian Rangers from 3 to 22 April, 2016. Operations will be coordinated and based from the Canadian Armed Forces Arctic Training Centre in Resolute Bay, NU. Activities will include surveillance patrols, small arms ranges and survival training training in the vicinity of Resolute Bay and Grise Fiord. Diving operations will take place in vicinity of Canadian Forces Station Alert.

All contaminated material will be treated as hazardous material and returned to Canadian Armed Forces Arctic Training Centre for proper disposal. Fuel will be transferred using existing transfer/dispensing system at Canadian Armed Forces Arctic Training Centre.
Fuel cache sites will employ a manually operated pump into approved containers or directly into vehicle.
Dispersed refueling points will have spill kits and drip trays available for use.

Out clearance inspections and site cleanup will be completed post Operations.



Joint Task Force (North) (JTFN) will conduct Operation NUNALIVUT 16 from 03 April to 22 April, 2016 in the Arctic, based out of Resolute Bay, Nunavut and Canadian Forces Station (CFS) Alert, Nunavut. The overall aim is to further enhance the Canadian Armed Forces' (CAF) knowledge and capacity to operate in austere locations and challenging environments, while allowing the CAF to demonstrate their ability to effectively respond to safety and security issues in the North.

Op NUNALIVUT 16 will be conducted with patrols on the land, on the sea ice, underwater, and in the air. It will consist of approximately 225 CAF personnel, and may feature participation by international partners. To facilitate the conduct of the Operation, JTFN will establish a Task Force Headquarters at the Canadian Armed Forces Arctic Training Centre (CAFATC) in Resolute Bay consisting of approximately 15 members with an additional 50 support personnel.

CAFATC will provide the logistics hub for this operation and military and contract civilian aircraft will operate out of the CAFATC airfield. Personnel transportation will include foot, snowmobile and over snow personnel carrier (BV-206). Additional Command and Control will be provided from a headquarters in Yellowknife, NT.

A Canadian Army Company supported by members of 1 Canadian Ranger Patrol Group (1 CRPG) for a total of approximately 120 personnel will execute patrols on the sea ice to the northwest from Resolute Bay, conducting training in Arctic survival skills and patrol Canadian Territory. A live fire exercise is planned to be conducted on the sea ice however the location is currently unknown. A small contingent of approximately 14 persons will also fly to Grise Fiord to perform a foot or snowmobile patrol near the community.

A Dive Team consisting of 20 personnel from the Royal Canadian Navy's Fleet Diving Unit (Atlantic) will be conducting both manned dive operations in CFS Alert. This activity will have a support team of approximately 20 personnel. In addition, the Dive Team will evaluate its cold weather diving ensembles and ice diving tactics, techniques and procedures.

Throughout this training, Rangers from 1 CRPG will guide and train soldiers on arctic survival and navigation.

Soldier accommodation will be a mix of barracks at CAFATC and CSF Alert and ten man tent while living on the land.
