**Re: Screening Decision for Agnico Eagle Mines Ltd.'s "Peter, Fox, and Parker Lakes" Project Proposal, Kivalliq Region**

Dear Ms. Bennett:

On October 21, 2015 the Nunavut Impact Review Board (NIRB or Board) received a referral to screen Agnico Eagle Mines Ltd.'s (AEM) "Peter, Fox, and Parker Lakes" project proposal from the Nunavut Planning Commission (NPC or Commission) with an accompanying positive conformity determination with the Keewatin Regional Land Use Plan. Please note that the referral from the NPC was triggered by cumulative effects concerns pursuant to subsection 80(1) of *Nunavut Planning and Project Assessment Act* (NuPPAA) and are related to:

- a) expired and active mineral interests nearby, including advanced projects,
- b) that this project could induce additional activity, and
- c) the area has been identified as having value and priority to local communities for:
  - i. caribou migration

- ii. general wildlife
- iii. muskox.

Pursuant to section 86 of the NuPPAA, the NIRB commenced screening this project proposal and assigned it file number 15EN049.

Following the assessment of all material information provided, the NIRB is recommending that a review of AEM's "Peter, Fox and Parker Lakes" project is not required pursuant to paragraph 92(1)(a) of the NuPPAA.

Pursuant to its discretion under paragraph 92(2)(a) of the NuPPAA, the NIRB has determined that specific terms and conditions are appropriate for this project.

Accordingly, the NIRB is issuing the attached Screening Decision Report dated January 18, 2016 to the responsible Minister(s). The Screening Decision Report provides, among other things, the regulatory framework, project overview and the NIRB assessment process, factors relevant for the determining significance of impacts and recommended project-specific terms and conditions.
