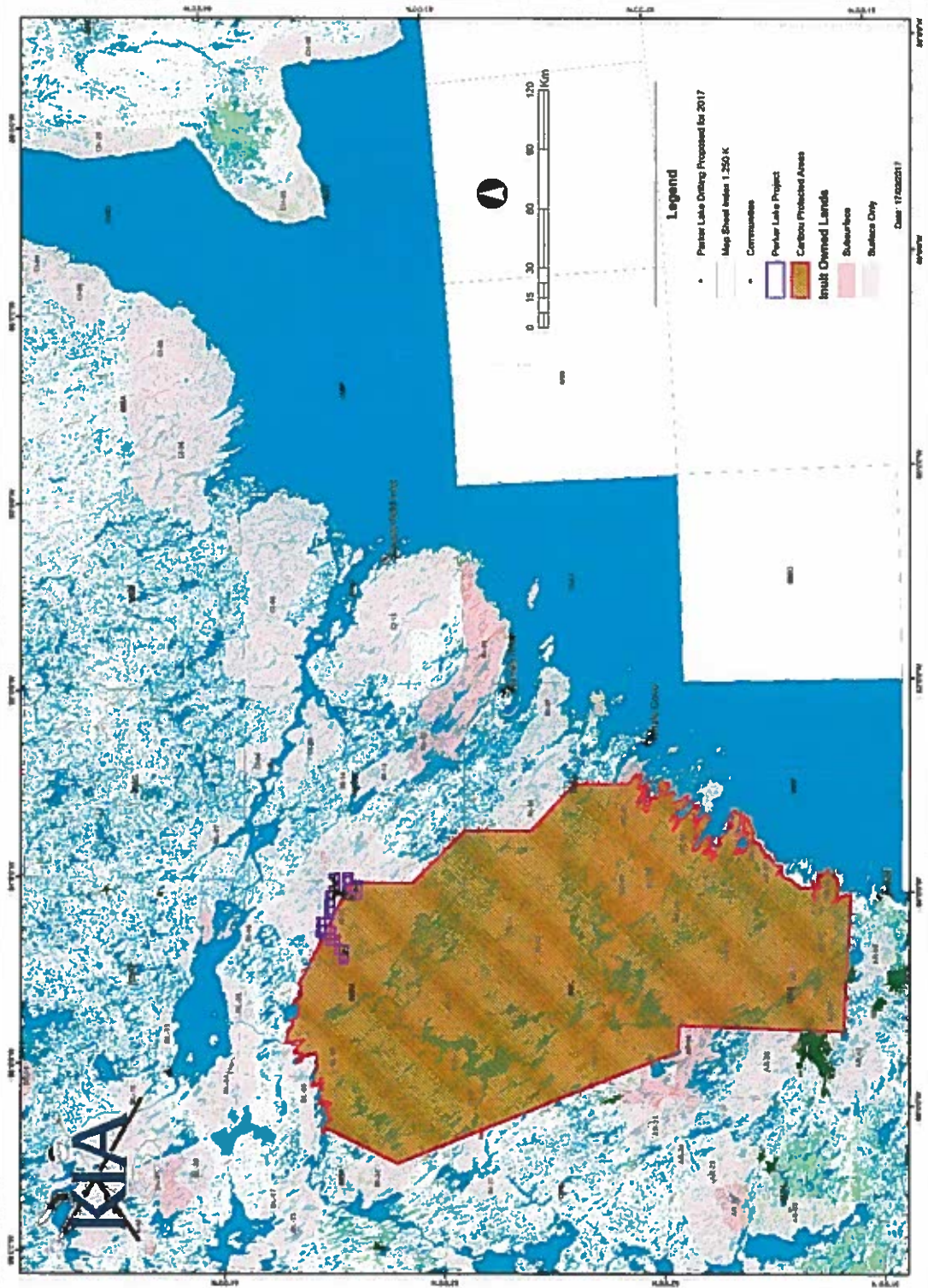
Until caribou research is completed by the Government of Nunavut It will be difficult to allow any activities in calving grounds.
