1 Summary




FIGURE 1: KAHUNA PROPERTY LOCATION

Dunedin Ventures Inc. (Dunedin) Kahuna Property is located between the communities of Rankin Inlet (Kangiqtiniq) and Chesterfield Inlet (Igluigaarjuk) in the Kivalliq Region of Nunavut (Figure 1). The property hosts known gold and diamond occurrences and comprises 145 mineral claims encompassing 166,463 hectares.

All exploration activities on the Kahuna Property are authorized by INAC Land Use Permit N2015C0019, KIA Land Use Licence KVL315B01, KIA Land Use Licence KVR16F01 and NWB Water Licence 2BE-KDP1722.

Exploration activities conducted in 2017 were low-impact and included soil, till and rock sampling, prospecting and staking and the collection of high resolution air photos using a small remote controlled drone. Drilling and bulk sampling was not conducted in 2017 and the overland winter trail was not utilized. No land-based equipment or vehicles were used in 2017.

The 2017 exploration program was based out of Rankin Inlet. No waste was generated on the property. Water was not required for exploration activities. Jet fuel for the helicopter was purchased from the Rankin Inlet airport. No fuel was placed on the property in 2017.

2 Corporate Background

Dunedin Ventures Inc. (Dunedin) is a Vancouver-based exploration company whose main focus is the Kahuna Property in the Kivalliq Region of Nunavut. Dunedin entered into an option agreement to fully acquire the property in January 2015.

Chris Taylor is the Chief Executive Officer and President, Tony Ricci serves as the Chief Financial Officer and Bob Singh is the Exploration Manager. Jeff Ward is the VP Exploration and Andrew Berry serves as the VP Operations. The group is committed to the social and economic development of the north while maintaining a level of excellence in minimizing environmental impacts.

3 Property Description & Location




FIGURE 2: KAHUNA PROPERTY 2017 LAND TENURE

With the addition of 36 claims staked in 2017, the property currently covers 145 mineral claims totalling 166,462.6 hectares (Appendix A). Claims are located on NTS map sheets 0550/02, 0550/03, 0550/04, 0550/05, 0550/06, 0550/07, 055J/13, 055J/14, 055N/01 and 055N/08 (Figure 2). The southern boundary of the property adjoins the north boundary of subsurface Inuit Owned Land (IOL) parcel RI-01, approximately 25 kilometres northeast of Rankin Inlet. The northeast and northwest corners of the property are located approximately 10 kilometres southeast and approximately 75 kilometres west of Chesterfield Inlet, respectively. The Property extends north, south, east and west between Latitudes 62°58' and 63°19' North and Longitudes 90°44' and 92°13' West (UTM coordinates: 6,983,000mN to 7,023,000mN and 539,000mE to 614,000mE, NAD83, Zone 15). A total of 82 mineral claims with surface rights covering 87,570 Ha are within, or partially within, the boundaries of surface Inuit Owned Land parcel CI-15.

Permits and licences enabling exploration work to be conducted on the property have been issued by the Kivalliq Inuit Association (KIA) for parts of the property covering Inuit Owned Lands (IOL), by Indigenous and Northern Affairs Canada (INAC) for Crown Lands and by the Nunavut Water Board (NWB). Additionally, Dunedin has a KIA Right of Way Licence for an approved overland winter trail from Rankin

Inlet to the Kahuna Property. 2017 was the third year that Dunnedin operated on the lands described in this report. See Table 1 for a list of active permits and licences issued for lands that comprise the Kahuna Property. Copies of the Kahuna Property management plans, permits and licences and the terms and conditions thereof, are available at the site office during operations and in the Vancouver head office.

4 2017 Work Completed

Work in 2017 included soil, till and rock sampling, prospecting (Figure 3) and staking and the collection of high resolution air photos using a small remote controlled drone. Ground crews were comprised of two to ten personnel with up to two helicopters. Wildlife monitors accompanied crews daily.

4.1 Prospecting & Rock Sampling




FIGURE 4: 2017 ROCK SAMPLE LOCATION MAP




FIGURE 5: 2017 PROSPECTING TRAVERSE LOCATION MAP

A total of 602 rock samples were collected along approximately 311 kilometres of prospecting traverses undertaken during the 2017 exploration program (Figures 4 and 5). The helicopter supported program was conducted between June 15 and September 28, 2017 and ran concurrently with the soil sampling program.

Rock samples were collected during ground traverses using a rock hammer or geotools when mineralization and/or favourable alteration was identified while prospecting. Approximately 1-5 kg of rock material is collected for assay and placed in a sample bag. Notes are taken at each sample site that include sample number, location, and geological characteristics.

Samples were shipped to Activation Laboratories (Actlabs) in Thunder Bay, Ontario for multi-element geochemical analysis and gold fire assays.

4.2 Till Sampling




FIGURE 6: 2017 TILL SAMPLE LOCATION MAP

Dunnedin collected 3478 till samples from across the Kahuna Property in 2017. The property-wide till sampling program was conducted over a period of 31 days between August 9 and September 17, 2017. Till sample traverses and sample sites were pre-determined with final sample locations being selected in the field based on ground conditions. Till sample locations can be seen in Figure 6.

Till samples were collected from frost boils or shallow holes dug into glacial till. Sample material was wet screened and undersized material (<3.36mm) was retained for the sample. The screened till samples weigh approximately 10 kg each. Notes describing the location, sample details and general comments were taken at every sample site.

Samples were shipped to CF Minerals Research Ltd. in Kelowna, British Columbia, for processing and diamond indicator mineral recovery.

4.3 Drone Surveying




FIGURE 8: 2017 DRONE IMAGERY COVERAGE

The 2017 exploration program included drone surveying which was conducted concurrently during the prospecting program. Approximately 109 km² of high-resolution images were collected on the Kahuna Property using a DJI Mavic Pro Quadcopter Drone (Figures 7 and 8). The Mavic Pro is a small, foldable drone that is operated by remote control. The purpose of the drone survey was to obtain high-resolution air photos over areas of interest on the property, including future exploration areas and to survey proposed sites for heritage occupation, prior to work.

4.4 Soil Sampling




FIGURE 9: 2017 SOIL SAMPLE LOCATION MAP

During the 2017 summer field season, four Dunnedin employees conducted a helicopter-supported soil sampling program. The work was conducted between August 10, 2017 and August 15, 2017. A total of 80 soil samples were collected over two grids. Soil sample locations can be seen on Figure 9.

The soil geochemical survey was designed to test the efficacy of assay methods for detecting gold in soils. Small soil grids were established over areas where previous heavy mineral concentrates from till samples returned gold grains and anomalous geochemical gold values. Sample grid coordinates with pre-determined sample sites were uploaded to handheld GPS devices daily prior to conducting field work. During collection individual sample sites may move several metres to obtain suitable soil media for analysis. Approximately one to two kilograms of material is removed from a small hole dug using a garden spade or shovel. Descriptive notes are taken at every sample site.

A total of 80 soil samples and 2 QA/QC samples were sent to Activation Laboratories Ltd. (Actlabs) in Thunder Bay, Ontario for analysis.

4.5 Staking

An additional 36 claims comprising 42,128 hectares were staked on the northern side of the property in September 2017. An application to record these mineral claims was submitted to the Mining Recorder's Office in Iqaluit on October 11, 2017. The claims are registered and currently pending final approvals from the Nunavut Mining Recorder. With the addition of the new claims the Kahuna Property now comprises 145 mineral claims and encompasses 166,463 hectares (Figure 2).

5 Wildlife Observational Log

The 2017 wildlife program consisted of logging incidental observations of all wildlife encountered by designated wildlife monitors and field staff. Any species at risk or high priority VEC (valued ecosystem components) encountered in the study area were noted.

Wildlife incidents, when they occur, are reported immediately to the KIA and to the GN Wildlife Biologists. Contact information for emergency situations are hung on the wall of the office and provided in Dunnedin's Environmental and Wildlife Management Plan. There were no wildlife incidents reported in 2017.

All Dunnedin personnel, contractors, consultants and visitors to the Kahuna Property respect the land, water and local wildlife. Staff make all efforts to mitigate and minimize any impacts while working in the project area.

During orientation and weekly safety meetings, all project personnel were made aware of measures to protect wildlife and are required to become familiar with Dunnedin's Environmental and Wildlife Management Plan.

6.1 Wildlife Mitigation Measures Summary

The following is a brief summary of the Wildlife Mitigation Measures included in the Environmental and Wildlife Management Plan (EWMP).

- Wildlife monitors hired from the Aqigiq HTO are responsible for documenting wildlife sightings, responding to wildlife interactions and implementing mitigation measures.
- Approaching and feeding wildlife is strictly prohibited.
- Harassment and disturbance of wildlife is prohibited.
- Hunting or fishing, while conducting business on behalf of Dunnedin, is prohibited.
- Nuisance wildlife is to be reported immediately.
- All employees and contractors will receive Bear Safety training which includes reading "Bear Safety-Reducing Bear-People Conflicts in Nunavut".
- Unless specified in permits or there is an unavoidable need for low level flights, helicopters will maintain a minimum altitude of 610 metres above ground level in places where there are migrating caribou, caribou cows and calves, muskoxen nurse groups and other wildlife or; follow flight altitude restrictions in applicable INAC and KIA permits.
- Helicopters will not land in any area where wildlife are present unless under an emergency situation.
- Flight altitudes must be strictly observed and recorded and pilots are responsible for enforcing flying limits.
- Raptors, migratory and breeding birds and their nests are not to be disturbed.
- In areas where colonies of birds are observed, the flight levels will be restricted to a vertical distance of 1000 metres and a horizontal distance of 1500 metres from birds.
- Cease activities that may interfere with the migration or calving of caribou or muskox, until the animals have passed or left the area,
- The Kahuna Property is approximately 100 kilometres from the nearest designated caribou crossing. No specified activities are to occur within 10 kilometres of designated caribou crossing and no diamond drilling operations are to occur within 5 kilometres.
- No activities are to act as a block or in any way cause a diversion to the migration of caribou.
- The Kahuna Property is not within any Caribou Protection Areas. The nearest calving grounds are approximately 65 kilometres from the property. In the event that caribou cows calve outside of the Caribou Protection Areas, Dunnedin shall follow caribou protection measures within the area occupied by cows and/or calves between May 15 and July 15.

To mitigate daily helicopter transits to and from Rankin Inlet, and for safety reasons associated with winter work conditions, Dunnedin is seeking authorization for a temporary field camp located centrally on the

Kahuna Property, along the approved winter trail and proximal to high priority exploration targets for the 2018 exploration program.

During the 2017 summer exploration program low level flights were kept to a minimum at all times. Dunnedin suspended operations for two days when bad weather prevented flying above 610 metres to avoid disturbing the herd. Helicopter flights were also detoured to avoid caribou when present and ground operations were moved to new areas when animals were observed.

Five wildlife monitors were hired from Chesterfield Inlet over the course of the 2017 exploration program. Wildlife monitors were responsible for recording wildlife observations and carried firearms as a safety precaution in the event of a bear incident. There were no wildlife incidents reported in 2017.

Mitigation measures were found to be effective during operational activities and no adjustments are recommended at this time.

7 Land Use Considerations

The land use area is to be kept clean and tidy at all times. All garbage and litter, including cigarette butts, were removed by personnel from all field sites and during daily operations.

No drilling or bulk sampling was conducted in 2017. All sampling activities conducted during the 2017 exploration program are considered low-impact, and were conducted by crews on foot with negligible surface disturbance. Soil and till samples are collected from small holes dug into the ground surface. All holes are backfilled after the sample is collected to minimize ground disturbance.

8 Regulatory Inspections and Reporting

Notification of program commencement and closure was provided to INAC, KIA, NWB, WSCC and NIRB. KIA was also notified of hiatus and resumption of operations and helicopter identification. No regulatory inspections were conducted on the property in 2017.

9 Fuel Inventory

No fuel was placed on the Kahuna Property in 2017. Jet fuel for the helicopter was purchased from the Rankin Inlet airport.

In preparation for the 2018 program, 250 drums of Jet A were shipped by sealift to Rankin Inlet and are currently stored at M&T Enterprises.

10 Flight Summary

The 2017 exploration program on the Kahuna Property was helicopter supported.

A Bell Long Ranger helicopter (C-GFEG) contracted from Great Slave Helicopters out of Yellowknife, Northwest Territories, was used to support the program between June 15 and July 15, 2017. The helicopter flew a total of 72.7 hours.

From July 24 to September 30, 2017, Custom Helicopters provided air support. A Bell Jet Ranger helicopter (C-PQS) flew a total of 53.8 hours for the prospecting program and 91.1 hours for the till sampling program and staking. Bell Long Ranger helicopter (C-GIPG) flew 89.6 hours during till sampling and staking.

The helicopters flew primarily between the Rankin Inlet Airport and sampling sites on the Kahuna Property. On board satellite tracking systems on the helicopters recorded locational coordinates at 2 to 4 minute intervals (A digital record of this data is available upon request).

11 Socio-Economic Impacts & Benefits

Dunnedin Ventures has committed to hiring local wildlife monitors through the Aqigiq HTO. The company hired five wildlife monitors from Chesterfield Inlet for the 2017 program. Dunnedin utilizes northern businesses and services wherever available. Dunnedin has also sent a letter of support to the Hamlet of Chesterfield Inlet for the Chesterfield Inlet Harbour Development Project and the Access Trail Road Route Project. A list of contractors whose services were utilized in 2017 is provided in **Appendix B**.

12 Community Consultation

The company is committed to consulting with local residents and conducts regular visits to Rankin Inlet and Chesterfield Inlet to discuss available Inuit Qaujimagatuqangit, exploration programs and any potential concerns the communities may have. Several meetings were conducted in 2017 to discuss Dunnedin's the 2017 exploration program, the proposed field camp, and plans for the 2018 exploration program.

The following is a summary of the community consultation conducted in 2017 thus far. Dunnedin's community consultation log is provided in **Appendix C**.

June 19, 2017: Bob Singh (Exploration Manager, DVI) took Simeonie Sammurtok (Mayor of Chesterfield Inlet) and Jerome Misheralak (Aqigiq HTO) to target sites on the Kahuna Property and the cleaned up Josephine Camp abandoned by Shear Minerals in 2010.

June 19, 2017: a public meeting was held in Chesterfield Inlet with members of the Hamlet, the KIA, and the HTO present. Wildlife monitoring and helicopter flight altitudes were discussed. Locals were concerned about helicopters and caribou. DVI informed them that the helicopter companies are aware of all rules and regulations and are not to fly over calving and post-calving caribou below 610 metres. Eli would like to see water testing at Josephine Lake. DVI offered to clean up the Sedna Camp but the KIA did the clean-up.

August 15, 2017: Chris Taylor met with Simeonie Sammurtok (Mayor of Chesterfield Inlet), Roy Mullins (SAO) and David Kattegatsiak (CEDO) to discuss the project.

August 15, 2017: a meeting was held in Chesterfield Inlet with members of the hamlet and the HTO to present a project update and discuss upcoming plans. DVI required two more Wildlife Monitors and would be conducting interviews the following day. The drill program was discussed. Solomon Autut asked what DVI would do to ensure the protection of the environment from fuel spills. DVI's Spill Prevention and Response Plan is in place to ensure that even when refilling, spill pads are in place and that all spills are recorded and reported. DVI avoids sensitive areas. A security deposit has been given to the KIA to guarantee that there is money to clean up the camp. All fuel will be stored in bermed containers.

August 16, 2017: DVI held a public meeting in Chesterfield Inlet. Leo was concerned about impacts of wildlife and the environmental caused by mining. DVI is an early stage project and it takes approximately 20 years from discovery to the development of a mine. There are communities and regulators involved in every step of the process to becoming a mine and if the community does not support the project then a mine will not go forward. It is too early to know if the Kahuna Property will ever become a mine. The

mayor supports putting in a camp and discussed talking with the HTO about helping to choose a site to make sure it's suitable.

September 28, 2017: Harry Aggark (Deputy Mayor of Chesterfield Inlet) and Jerome Misheralak (HTO) were flown around the Kahuna Property to inspect possible camp locations. Harry and Jerome inspected the proposed camp location and deemed it suitable.

September 29, 2017: DVI had a meeting with the KIA to discuss field operations. Topics discussed during the meeting included helicopter altitudes and best practices, caribou protection measures, prime hunting season, community consultation, environmental/wildlife specialists, communication.

October 24, 2017: a public meeting was held in Chesterfield Inlet. Members of the Hamlet, CLARC, HTO, KIA and the community were present. Leo suggested a different route for the overland winter trail due to climate change as it might be dangerous driving over sea ice. Harry mentioned that the route has been used in the past and since it's approved by the KIA it should be good. Discussed local hires and the desire for Inuit Qaujimagatuqangit be a part of the exploration.

October 26, 2017: DVI had a meeting in Rankin Inlet with members of the Aqiggiag HTO, CLARC, KIA and the Hamlet. DVI recognized the concern community members had raised regarding helicopter flights out of Rankin Inlet. To mitigate this the company has proposed the establishment of a new field camp on the property. The camp would be established on INAC lands approximately 40km from Rankin Inlet and on the route of the permitted winter trail. Harry said the proposed camp site was good and the type of site that Inuit would look for. Jeff suggested the company contact the cabin holders in the area of the proposed camp. Comments received were supportive and there were no other concerns raised.

13 Archaeology, Traditional Knowledge

An archaeological reconnaissance survey was conducted by Golder Associates Ltd. between August 29 and September 1, 2016 under Archaeological Permit No. 2016-21A. The reconnaissance focused on ten areas identified for drilling and/or bulk sampling and two low level aerial passes along the 46 kilometre long overland winter trail were undertaken. Aerial reconnaissance did not identify any archaeological sites within the vicinity of the proposed camp. As required by territorial and federal legislation, no operations will be conducted within 30 metres of a known archaeological site.

As part of the 2017 investigation for a camp location high resolution air photos were collected over several different potential camp sites. There are no archaeological features evident in the high resolution air photos collected over the selected camp area.

A ground examination was conducted by Harry Aggark (Deputy Mayor of Chesterfield Inlet) and Jerome Misheralak (Aqigiq HTO) in September 2017. There were no archeological features noted. The site was deemed to be best location for a field camp. No concerns were addressed and both men recommended the camp location.

Additional archaeological studies will be carried out if any artifacts or sites are identified during ongoing work. No work will occur in any area where a known archeological site has been located. If any employee or consultant finds an archeological site, work must cease immediately, the GPS coordinates are recorded and the finding is reported immediately to the Project Manager who will report its location to the Department of Culture and Heritage (Government of Nunavut), the Land Administration Division at INAC and KIA. Handling of any archeological artifact is strictly prohibited.

I'd like to time my trip so that you're in town. Maybe we can sit down over some maps when in town as well, so I can get a better idea about your community's use of the land in various areas so we can plan accordingly?</p> <p>We also need at least two good guys that can head out with us as wildlife monitors for about a month. We used two guys from Rankin Inlet last year, but I'd rather use people from Chesterfield if you have anyone available. They'll need to take notes of all the wildlife we see and also have rifles just in case. If you can recommend anyone suitable, we'd really appreciate it. We also need advice on how to finalize our wildlife monitoring and impact reduction plan, so maybe if we can meet for a day and then head out on the land for a couple days afterwards that would work?</p> <p>I was in Ottawa earlier this month and thought I might have time to meet up with you while you were there, but my mother who I was visiting is quite sick and I just wanted to spend time with her. I'm not sure if Denise said I was going to meet up with you or not, but I spent the whole time with my parents so didn't get any meetings or anything else done.</p> <p>I should mention I haven't heard anything back from the KIA yet about when they're planning to start cleaning up the Josephine Lake camp. I gave them a formal letter saying we'd help clean it up once they started, my idea was to helicopter people or material to and from the site during clean up when we were out there working anyway doing our geological mapping. It would be a waste of a good opportunity if they can't get their plans together in time this year. Maybe if they'll let us access the camp, we can at least go out there with a couple of guys and clean up some of the trash that's blown out onto the tundra from the ripped up tents? It would be a start anyway. I don't really understand what the delay is there, Luis Manzo said it was legally complicated but the longer that stuff is out there the more there is to clean up, and the less useful all the wood and equipment is to the communities.</p> <p>Please give me a call back whenever you like, my cell phone is 778 938 5298.</p> <p>Best regards Chris</p>

He asked if the company would be sampling from frost boils – where there is a higher concentration of minerals. Chris said yes they would be. It was agreed that the activities proposed to start on Aug 26, 2016 were low impact and could proceed as proposed. Harry Aggark and Peter Kattagatsiak had been flown to the proposed exploration sites the day before and agreed that work could proceed. Chris suggested that the company could fly community representatives each year prior to activities to endorse the activities and provide recommendations in advance of exploration. 			<p>As an example, Chris stated that a sampling hole or “crater” had been left in one location from previous exploration, but then showed a picture of the site that Denise had taken that week along with Peter and Harry during the helicopter site visit, and it was determined that the “crater” was actually only a few feet deep. He further explained that a sample would need to be collected next year at that location, so that more diamonds could be recovered and a valuation obtained. While rocks left behind by Shear are too large to move by hand, equipment used by Dunedin to collect a sample there could fill in the shallow hole and tidy up the area after Dunedin’s sampling was complete.</p> <p>Drilling was discussed as being used in the future, potentially starting in 2017. Pictures of drill sites from Shear’s past work was shown and it was shown there was minimal remaining impact from those activities. Photographs of drill rigs from other projects were shown for reference. Drilling is less invasive than blasting or trenching, but that drilling would still only occur when wildlife were not present.</p> <p>Chris asked that a community member (eg HTO member) accompany him before each exploration program, so that current information could be shared with regards to wildlife activity and the environment.
