This letter will serve to advise you that Sabina Gold & Silver Corp. will be resuming operations for the season at the Back River Project on or about February 15th, 2018.

The following exploration programs are currently anticipated to occur in 2018 at the Back River Project:

- February 15th to May:
 - Limited personnel will be on site for the first week; with initial activity limited to camp opening tasks, such as snow clearing, warming up buildings, starting equipment, etc.
 - Approximate 10 week winter exploration drilling program at Goose camp.
- Mid-June to mid-September:
 - Approximate 3 month summer field based and fall drilling exploration program at Goose camp.

On December 19th, 2017 the Nunavut Impact Review Board (NIRB) issued the Project Certificate (PC) No. 007 for the Back River Gold Mine Project (NIRB File No. 12MN036) to Sabina. Sabina is bound by the PC Terms and Conditions and iterates our commitment to compliance. A Type B Water Licence application and supporting documents was submitted to the NWB for proposed 2018 initial development works related to the Back River Project. The Type B Water Licence will allow for the mobilization of equipment and materials, construction of initial infrastructure, and/or to undertake development works in support of future development of the Project. Refer to Table 1 for a list of potential 2018 initial development work activities.
