I am the Technical Advisor at NIRB that has been assigned your Whale Cove Area Exploration project proposal.

Can you please confirm if, similar to the Huckleberry Project,

- Drilling will be both on-land and on-ice?
- Trenching will be bedrock exposition by overburden removal?
- Waste /sewage incineration would be with a dual chamber incinerator?

Also, will there be an airstrip constructed at one of the four new exploration sites, or will the airstrip at Huckleberry serve this project as well?

And, will the transport of material and equipment during the winter with the Challenger tractors be coordinated with transport to the Huckleberry sites? i.e., will loads be shared, or will each project have its own dedicated Challengers?
