## PROJECT SCOPE:

The proposed “DEW Line Sites Water Licence Renewals” projects which would be located in the same areas as previously approved and would be located within the Qikiqtani (South Baffin) and Kitikmeot regions. The Proponent intends to conduct amend the scope of previously approved activities to include a hydrocarbon landfarm at each of the four (4) sites with the timing for the activities. The program is proposed to take place from March 2019 to March 2029. The scope of this proposed project as identified by the NIRB includes the following undertakings, works or activities:

- Testing and release of berm water from fuel storage facility
- Construction of landfarm for remediation of hydrocarbon impacted soils
- Treat contaminated water as HAZMAT;
- Use of a helicopter and fixed winged aircraft to access each main site as well as adjacent sites
