On August 2nd, 2018, we received the notice of the above-mentioned project that you sent us.

According to the *Canadian Environmental Assessment Act, 2012* (CEAA 2012), an environmental assessment may be required for projects that include one or more designated activities listed in the *Regulations Designating Physical Activities*. Taking into account the information contained in the project notice we received, we understand that your project does not correspond to a designated activity. However, please note that pursuant to paragraph 14(2) of CEAA 2012, the Minister of Environment and Climate Change has the power to designate a project not listed in the *Regulations Designating Physical Activities* if he or she is of the opinion that this project may have adverse effects or that public concerns about these effects warrant it.

In the event that changes are made to your project, it is your responsibility to verify that it corresponds to a designated activity listed in the regulation and to file a project description with the Canadian Environmental Assessment Agency, where applicable. 

Merci d'avoir pris le temps de me parler ce matin. Bien apprécié.

As discussed, here is a quick overview of the project.

In 2015 a prefeasibility study was done to look at fiber in the Nunavik region, in parts of Nunuvut and the northern Labrador coast.

Financial considerations have limited the scope of the project to an application being made under the Connect to Innovate fund.

This year we are undertaking a marine (bathymetric) survey of the bay. Map attached.

The results of the survey are to allow us to craft an RFP for a build next year.

A couple of questions.

1. For the marine survey, was a CEAA permit required? We understood it was not since it is a passive activity overall.
2. For the build next year, I believe CEAA would need to be involved.

I look forward to following up with you on this .
