**RE: 19XN011 – Qulliq Energy Corp. – Kugluktuk Power Plant and Solar Energy Project Proposal – NIRB Screening**

Environment and Climate Change Canada (ECCC) has reviewed the information submitted to the Nunavut Impact Review Board (NIRB) regarding the above-mentioned screening and is submitting comments via email. ECCC's specialist advice is provided based on our mandate, in the context of the *Canadian Environmental Protection Act*, the pollution prevention provisions of the *Fisheries Act*, the *Migratory Birds Convention Act*, and the *Species at Risk Act*.

The following comments are provided:

Comment

Section 7.2 Important Phone Numbers lists the contact number "Environment Canada (Emergency) Yellowknife 867-669-4725" (Page 3).

In the case of a spill or emergency, the 24 Hour NWT/NU Spill Report Line should be contacted first by the Proponent. The NWT/NU Spill Report Line will then involve ECCC Emergencies when appropriate.

For information relating to the environmental enforcement and reporting requirements in the *Canadian Environmental Protection Act* and the *Fisheries Act* the Proponent can contact ECCC Environmental Enforcement at (867) 669-4730.

#### ECCC Recommendation(s)

ECCC recommends that the Proponent remove the Environment Canada (Emergency) Yellowknife phone number from the Spill Contingency Plan.

## **2. Species at Risk**

#### Comment

The Proponent has not identified species at risk which could be encountered at, or affected by the Project.

Subsection 79(2) of the *Species at Risk Act* states that during an assessment of a project, the adverse effects of the project on listed wildlife species and their critical habitat must be identified, that measures are taken to avoid or lessen those effects, and that the effects need to be monitored.

The location of the Project falls within the range of several Species at Risk which could be encountered. Table 1, provided below, lists Species at Risk that may be encountered in the Project area that have been designated as at risk by COSEWIC as well as their current listing on Schedule 1 of the *Species at Risk Act* (and designation if different from that of COSEWIC).

If species at risk are encountered or affected by the Project, the primary mitigation measure should be avoidance. The Proponent should avoid contact with or disturbance to each species, its habitat and/or its residence.

Notes: <sup>1</sup> Fisheries and Oceans Canada has responsibility for aquatic species. <sup>2</sup> Environment and Climate Change Canada (ECCC) has a national role to play in the conservation and recovery of Species at Risk in Canada, as well as responsibility for management of birds described in the <i>Migratory Birds Convention Act</i> (MBCA). Day-to-day management of terrestrial species not covered in the MBCA is the responsibility of the Government of Nunavut (GN). Populations that exist in National Parks are managed under the authority of the Parks Canada Agency.				

### ECCC Recommendation(s)

ECCC recommends that the Proponent identify any potential Project effects and provide mitigation for any species at risk that could be encountered and affected by the Project.

ECCC recommends that the Proponent undertake monitoring of Species at Risk mitigation. This should include recording the locations and dates of any observations of Species at Risk, behaviour or actions taken by the animals when Project activities were encountered, and any actions taken by the Proponent to avoid contact or disturbance to the species and its habitat.
