PROJECT OVERVIEW

Project Scope:

The proposed “Arviat Fuel Capacity Increase” project is located within the Kivalliq Region, within the Hamlet of Arviat. The Proponent intends to build a new tank farm and decommission the existing resupply pipeline and tank farm. The construction program is proposed to take place from May 2023 to October 2025 with the operation of the new fuel tanks proposed to be 25 years.

According to the project proposal, the scope of the project includes the following undertakings, works or activities:

- Construction of a new tank farm:
 - Construction of access road;
 - Construction of a containment area, new tank foundations and concrete apron for tank refuelling;
 - Construction of three (3) 3.333 million litre diesel storage tanks with associated fill and supply piping;
 - Construction of one (1) 3.333 million litre gasoline storage tank with associated fill and supply piping;
 - Construction of new dispenser and operator shelter buildings;
 - Use of up to 3,500 m³ of water for hydrostatic testing of new tanks;
 - Water to be either freshwater or combination of salt water and fresh water;
- Decommissioning of existing resupply pipeline and tank farm:
 - Draining and cleaning of resupply pipeline and storage tanks;
 - Excavation and removal of existing resupply pipeline;
 - Removal of existing fuel tanks;
 - Remediation of hydrocarbon-contaminated soil;
- Relocation of shore resupply manifold;
- Use of heavy equipment and vehicles including dump trucks, cranes, excavators, and loaders for site preparation and construction of new infrastructure, and decommissioning and removal of old infrastructure;
- Sealift of new materials and equipment to Arviat as necessary; and
- Use of facilities in Arviat for accommodations, water source, and waste management and purchasing of local supplies for local and non-local construction workers.

At this time, the NIRB has identified no additional works or activities in relation to the project proposal. As a result, the NIRB will proceed with screening the project based on the scope as described above.
