Transport Canada (TC) received the Nunavut Impact Review Board (NIRB) letter dated April 12, 2019, requesting parties to review Agnico Eagle Mines Ltd.'s (AEM) – *Meadowbank Gold Mine Project and Whale Tail Pit Project 2018 Annual Monitoring Report* and provide comments with respect to jurisdictional authority and/or area of expertise. TC reviewed the *2018 Annual Monitoring Report* and offers the following comment:

Annual report section 11.2.3 refers to the following:

11.2.3 Baker Lake Fuel Farm Expansion Project

As a result of ore hauling from the Approved Whale Tail Pit Project to Meadowbank, and the addition of a Power Plant and heating facilities at the Whale Tail site, diesel fuel needs have increased and calculations made prior to the Approved Project permitting process underestimated the requirements of fuel. To address the upcoming shortage, Agnico Eagle is proposing to add two (2) 10 million L diesel fuel storage tanks to the Marshalling Area Bulk Fuel Storage Facility in Baker Lake for a total of 80 million litres. Proposed infrastructures would be built starting in April 2019 pending all regulatory approvals have been received by then.

TC comment: If Agnico Eagle Mines expands their Oil Handling Facility at Meadowbank, their Oil Pollution Emergency Plan would need to be updated to reflect the changes in the facility's characteristics.
