PROJECT SCOPE:

The proposed “*MS ROALD AMUNDSEN: Northwest Passage – In the Footsteps of Roald Amundsen*” project is located within the Kitikmeot and Baffin regions. The Proponent intends to conduct vessel-based tourism activities that would provide passengers opportunities to engage in sightseeing, zodiac cruising, kayak excursions, wildlife watching, shore landings for guided interpretive walks, and organized community visits. The program is proposed to take place from August to September 2019. The scope of this proposed project as identified by the NIRB includes the following undertakings, works or activities:

- Use of cruise vessel, the *MS ROALD AMUNDSEN*, for transportation and accommodation of up to 480 passengers/tourists, 170 crew members and one (1) contracted ice pilot;
- Use of a fleet of seven (7) zodiacs (small boats) fitted with outboard engines;
- Use of 18 kayaks for guests and instructors; and
- Tourism expedition visits(Dundas Harbour/Crocker Bay, Beechey Island, Prince Leopold Island, Conningham Bay, and James Ross Strait, Pond Inlet, Gjoa Haven and Cambridge Bay).
