Hi Erin,

Please find attached the staff schedule for Term and Condition 48 of Project Certificate 008, which has information on transferable skills.

Regarding your question on trades registration, Agnico Eagle has not registered all trades, occupations and journeypersons with the GN, although all apprentices are registered. This being said, we are in constant communication with the Department of Family Services who oversee the trades, occupations and apprentices in Nunavut, and we (Agnico Eagle and GN) work closely together to ensure the progression of registered apprentices. In other examples of our close working relationship, we have often provided support to Family Services in the trade accreditation process and to supply some of our workers to represent Nunavut in program revision workshops for the Red Seal Certification. Therefore, should the GN have need to work together on other registration, or require information to the support of training initiatives and programs, this is something we can further discuss with them.





Regarding your question on the sharing of information with KvSEMC, the staff schedule was not shared at the last meeting but we can consider presenting a high-level overview of the staff schedule at the next KvSEMC meeting.

We are available to discuss with you at your convenience, if needed.
