Reference: Withdrawal of Project Proposal 19YN038 “Unnamed Lake Water Supply Studies:

On August 9, 2019, the City of Iqaluit (City) received Ministerial approval of an amendment to water licence 3AM-IQA1626 allowing supplementation of the City’s water reservoir Lake Geraldine from the Apex River and Unnamed Lake under emergency circumstances. In its application to the Nunavut Water Board, the City proposed an extensive monitoring program inclusive of water level and flow monitoring in Unnamed Lake and Apex River tributaries. This program was referenced in a Letter of Advice from Fisheries and Oceans Canada 19-HCAA-00969 as a condition of approval of the proposed program.

As the scope of the monitoring program associated with the “2019 Emergency Amendment” of 3AM-IQA1626 is inclusive of the activities proposed in the project proposal “Unnamed Lake Water Supply Studies” (NPC File #149188; NIRB File 19YN038), the City is withdrawing this project proposal.
