Re: Additional Information Required: Information Request #2 for Wild Year Production's "Wild Canadian Year" Project Proposal

Dear Alex Burr:

On February 24, 2016 the Nunavut Impact Review Board (NIRB or Board) received the Wild Year Productions Ltd.'s "Wild Canadian Year" project proposal from the Nunavut Planning Commission (NPC or Commission). The NIRB assigned this project proposal file number **16YN007**.

Following receipt of the project proposal, the NIRB undertook a preliminary completeness check and found that the proposal did not contain sufficient information for the NIRB to permit proper screening. Pursuant to subsection 144(1) of the *Nunavut Planning and Project Assessment Act* (NuPPAA), on March 4, 2016 the NIRB requested that additional information from the Wild Year Productions Ltd. be provided to the Board. The NIRB followed up with the Proponent on numerous occasions via email (March 29, 2016, April 20, 2016) requesting an update on when the additional information would be provided. To date, the Board has not received the requested information or notification regarding when the information will be made available. Please note that if the proponent fails to submit the requested additional information, the Board may suspend or terminate the assessment activities of the proposed project pursuant to subsection 144(2) of the NuPPAA. Therefore, it is in Wild Year Productions Ltd.'s best interest to cure the identified information deficiencies in a timely manner.

The NIRB is again requesting submission of the information as enclosed and for the information to be provided by **May 13, 2016**. If Wild Year Productions Ltd.' determines that the time required to supply the required information is significantly greater than one (1) weeks, the Board requests written notification and an anticipated date for submission be provided as soon as possible.
