RE: NPC File # 149240 [Carboniferous Basins in Svalbard, Canada and the Barents Sea (CBS2)]

The following works and activities have been proposed in the above-noted project proposal:

1. Scientific research: Renewal of the project that was not completed last year. Investigation of the geometry, kinematics and faulting activity of NW-SE striking faults and to evaluate their impact as potential transfer/transform faults on (early) Carboniferous basins and subsequent Cenozoic break-up in Svalbard, the Barents Sea and Arctic Canada, using seismic, aeromagnetic, bathymetry and structural fieldwork data.
2. Related NPC FILE No: 148949; Related NIRB FILE No. 18YN051
3. Location: Qikiqtani Region; [North Baffin, Near Resolute bay, Devon Island]

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. The activities associated with this proposal were previously reviewed by NPC, and a conformity determination was issued on December 7, 2018, which still applies. In addition, the activities were previously screened by the Nunavut Impact Review Board (NIRB FILE NO.: 18YN051). The above-noted project proposal is exempt from screening by the NIRB under section 12.4.3 of the Nunavut Agreement as amended because it is for a component or activity that was part of the original proposal and its inclusion is not a significant modification of the project.
