The Nunavut Impact Review Board (the NIRB) has circulated a public notice of the screening for Canadian Arctic Holidays' "Clyde River Land Use Permit" project proposal and invited interested parties to provide comments by January 31, 2020.

Although the commenting period has not ended, the NIRB has received comments from CIRNAC and would like to provide an opportunity for Canadian Arctic Holidays to address the comments prior to the Board rendering its determination for this screening assessment.

A summary of CIRNAC's comments relate to the following:

- Recommendation that the Proponent provide a brief written summary of its interaction with Hamlet of Clyde River and community members.

Request that the Proponent provide clarification for their determination that their project will have a positive impacts on ecosystemic components (water quality, vegetation, wildlife etc.) as filled out in the Impacts Matrix in the provided application.

- Recommendation to incorporate Inuit Qaujimagatuqangit
- Recommendation to brief community members on project activities
- Recommendation to train and provide economic opportunities to local community members.
