| <p>The proposed project is located within the boundaries of the proposed Agguttinni Territorial Park.</p> <p>Nunavut Parks and Special Places is currently in the process of working with community stakeholders to formally establish Agguttinni Territorial Park. The Agguttinni Territorial Park Master Plan has been developed by the Clyde River Community Joint Planning and Management Committee (CJPMC) and has been approved by the Government of Nunavut.</p> <p>The Clyde River CJPMC is beginning to develop the park's Management Plan. It is unknown whether Canadian Arctic Holidays' "Clyde River Land Use Permit" project proposal will align with the final terms and vision of this Management Plan.</p> <p>The GN is concerned with the timing of this proposal as, if approved at this time, it may force the CJPMC to accept activities or uses within Agguttinni Park without having first an opportunity to review, comment, or make recommendations on the activities and uses proposed in this project.</p> |  |
