Hello Bhabesh,

Thank you for the response. For the fuel requirements mentioned below, for operational and maintenance purposes of the Utilidor System, as well as fuel requirements for any of the continuing construction that was licenced under the Type

“B” Licence (eg. Upgrading the water treatment plant) can you please specify whether there is project specific fuel storage or the equipment gets fuel from municipal stores.

In your application there is mention that the airport facilities use 5000 cubic meters of water annually which is trucked. As well, sewage is trucked to a sewage lagoon which will be decommissioned in the future but is currently under the Type “B” Licence which is switching to a Type “A” Licence. Although trucking sewage and water is not considered infrastructure it is an activity that will be continuing under the Type “A” water licence that is being applied for, unless I am mistaken. If so, please specify whether there is project specific fuel storage or the water and sewage trucks get fuel from municipal stores.

We are talking about only **licensed facility (Infrastructure) Utilidor system** which consists of Water treatment plant, Pump station, buried water pipe and buried sewer pipe and Macirator unit. These are the individual infrastructure under this Water Licence. Fuel consumption is for these operational and maintenance purposes only as and when required using different types of **Equipment. It means fuel is for the Equipment operation only.** Water truck or sewage truck are not considered Infrastructure and these are not under the Water Licence.
