This email is to request that, due to the recent developments on the COVID-19 situation, and since our intent is to work towards the common good to protect health and prevent the spread of this outbreak, Agnico Eagle will seek a two week extension to the deadline of April 7th, 2020 for the submission of the 2019 Annual Report. The consolidated report will be submitted on or before April 21st, 2020.

Agnico Eagle is monitoring the COVID-19 situation closely and has recently taken steps to provide teleworking for some of employees from the North as well as from the South along with sending home all Nunavummiut workers. Considering the remote nature of our Nunavut operations, the focus has been to enhancing the health and hygiene protocols in place to further protect our employees. For these reasons, there has been a shift in resources and time allocated to deal with COVID-19 which will create delays in reviewing the report.
