This letter is to notify Crown-Indigenous Relations and Northern Affairs Canada ("CIRNAC"), the Nunavut Water Board ("NWB") and the Nunavut Impact Review Board ("NIRB") that 5530 Nunavut Inc., a wholly owned subsidiary of Western Atlas Resources Inc., will be commencing mineral exploration activities at the Meadowbank Project.

The 2020 program is expected to start on July 10, 2020. The 2020 exploration program activities will comprise of up to 4,000 diamond drilling for a total of 13 drill holes at 7 platforms. Please find below locations of the drill platforms and fuel cache:
