Imaruqtirvia 9-mi, 2020-mi Nunavumi Avatilikiyin Katimayin (NIRB) titiraqtauhimayut Nunavunmi Parnaiyit Katimayiit (NPC taapkualuuniit Katimayiit) qauyihaiquplutik Sabina Kuluut Haviillu Kuapuriissat (Sabina) “Hanningayumi 2020-mi Havaaghanut Ihuaqhaitighat” havaaghanut tughirautinit naunaiqhitiyuq taimaa havaaghamut tughirautit hilataaniittuq nunam atuqtitauyut nunat parnaiyautainit. Katimayiit tughirautinik NIRB-kunnut qauyihagtittiyaat hanayaghanik huliyaaghaniklu tughirautainut hivuanit ilaunngittut taapkununga ihuaqhaqtauhimayunut tughirautinut talvuunalu ihuaqhaiyaghariangmat angiqtauhimayunut havaaghanut taimaalu ataagut Ilanga 12.4.3 talvani *Angirutait taapkua Inuit Nunavunmi Nunataarvianit taamnalu Nanngariyauyuq Kuit pilaarutaigut Kanatami* (Nunavut Angirutait) qauyihagtauvarialik NIRB-kunnit piinnariialutinik aittuqhitinnatik, laisiutiniklu ahinikluuniit angiqtauvariaqaqqat ilauyut Aulapkaiyit Atannguyainit. Katimayiit kinguanilu naunaiqhitiyut taimaa navalliyayunik ihuilitiqalaaqtuq qauyihaghimayainnit hivulliqmi qauyihatqiktauuyughaq. Imaruqtirvia 10-mi, 2020-mi Sabina tunihimayut “Hanningayumi 2020-mi Havaaghanut Ihuaqhaitighat” havaaghanut tughirautinik Katimayiit ihumaliuqtaghait kinguanilu ahiagut naunaiqhitiyimayut Imaruqtirvia 16-mi, 2020-mi.

Hapkua titiqqat naunaiqhitiyut aallanguqhimayunik havaaghainut huliyaaghainullu ilauyut tajja Hanningayumi Havakvingnit. Ilaupluni Katimayiit havaaghainut ihumaliuriamik aallanguqpaalliqhimayunik, ilauyut tajja uqauhiinik tuhaqtittiinnarialgit tughirautinut. Kinguani ilauyunit tuhaqtaarumik uqauhiinik, NIRB-kut havauhighanut ikayuqpangniat ihumagiplugit kinguani havaaghait ihumaliuqhimayainit NIRB-kut hapkunani tughirautinit Sabina-kunnit.

Titiraqhimayutut Imaruqtirvia 10-mi Imaruqtirvia 16-milu tughirautinit, Sabina-kut ilitturihimaliqtut tughirautauyunik ihuaqhautighanik nakuruttiqlugu amirnaiqpaalliqlugu Hanningayumi Havakviit. Sabina-kut ilittuqhitihi mayut taimaa ihuaqhautit ilihimaliqtait ihuaqhaiyaghanit ihivriughiplutik hannaviinit havaghutiklu laisitaarvianit taapkuninnga Nunavunmi Imaliqiyit Katimayit Qanugittunia A Imarmut Laisiutinik. Tughirautauyug havaaghaq ungahiaqtuq 400 km-nik hivuraanit ualiniqhianit nunallaarmit Iqaluktuuttiaqmit, 95 km hivuraanit kivalliqhianit hivuraat Qingauk, taimaalu 520 km-nik tununngaanit kivalliqhianit Yellowknife-mit, Nunattiami. Tughirautauyut ihuaqhautighat hivulliqnit havaaghanit ilaqturumaplugu tajja piinnarialiutilik mittarvik talvani Goose Nanminianit talvanilu Umiat Tullakvianit; ilaqtuqlugu parnaiyaqhimayut nunam iluani havaangit talvani Umwelt; ihuaqhaitjutighat kuvvikuit hiqupluqhimayut tutquumavighaat; hinaani hittiriitkuhiqlugu talvani tullakvingmi; uqhughat qattaryughainik tullakvingmi ihuaqhaqlugulu ukiumi apqutauyug. Sabina-kut naunaiqhitiyut taimaa 2020-mi Ihuaqhaitjutighat ihumaliuqtaunngittuq talvuuna “aviktuqhimayunit hanayaghanit” aallannguutit ilaunnginnamik hanayaanik ilaqtuqtaanik uyaraghiuqvingmi. Kingulliqaamik, Sabina-kut naunaiqhitihi mayut taimaa ilittuqhiyuittut huli havakvighainik hapkuninnga Havaaghanut ihuaqhautighait hanavighaanit kihimi naunaiqhitihi mayut ihuaqhautighainut havaaghainik Sabina-kut aullaqtiqniariaghainik. Ihuaqhaitjutighat tughirautinit hivituhiniaqtaat havaaghait 12-nik ukiunik tajja tughirautauhimayunit 10-nguplutik ukiut ahiillu aviktuqhimayut havaaghat aajjikkiingniaqtut.

Havaaghait ilittuqhitihi mayut talvani “Hanningayumi 2020-mi Havaaghanut Ihuaqhaitighat” iliqahiutihi mayut hapkua havaanguyut, havaaghat huliyauyullu:

- Goose Havakvia:
 - Ilaqtuqlugu Umwelt-mi nunam iluani havakviat 650 metres-mit (m) itinianik talvunga 900 meters-nut uyaraghiuriamik uyaraktalgit katiqhuqviit;
 - Ilaqtuqlugu Goose-mi ukiuraaluk milviuyuq talvanngat 1,500 metres-nit taimaa 47 metres-nit (5,000 x 150 feet) talvunga 1,800 x 61 metres-mut (6,000 x 200 feet);
 - *Atuqhimmaaqlugu* ukiuq tamaat hikumi milvik;
 - Imaqtuqpallialutik talvanngat 502,000 cubic meters-mit (m³) talvunga 822,450 m³-mut ukiuq tamaat, imaq *imiqtaqtauluni* huli Goose Tahianit Tahiryuamillu;
 - *Aulahimmaaqlutik* angiqtauhimayut hannaviit atuqlugit ikluqpaliuqhimayullu Goose-mi Nanminianit;

Sabina-kut inmingnik qauyihaihimayut tamangnut tughirautauyunik ihuaqhaitjutighanik taimaalu ilihimaliqtut, ihumaigut, aallannguqtirutit tughirautauyut ihuaqhaitjutighaitpallaqtut angiqtauhimayunut havaaghanut. Kihimi, Sabina-kut naahuriyut taimaa ihuaqhaitjutighaanit titiraqhimayuqarniarahugiyaat taimaa NIRB-kut munaqhitjutainit naunaiqhitiqumimayut, taimaalu, iniqhimaniagut, uqauhirnik tuhaqtittiquvangniat taamna Havaanguyuuq Titiraaqtaq Nappa 007 Uqauhiit Maliktaghallu ihumaliuqtauyariaghait.

Ilitariplugit aghuurnaqtut havaaghait inuit ayurnaqtunullu uqauhiit ikayuutaayut hanayunut uqauhirnik maliktaghaniklu talvani taja Havaariyaayum Titiraaqtanik, NIRB-kut uqauhirnik ilaayunit tuharumayut ihumaliuqtinnatik taimaa tughirautauyut aallannguqtirutit ihumaliutqiktauyaaghait talvani taja Havaaghanut Titiraaqtanik Nappa 007-mi ihumagiplugu Ilanga 12.8.2 talvanngat *Nunavunmi Angirutit* talvanilu ilanga 112(1) talvanngat *Nunavunmi Parnaiyaiyit Havaaghaniklu Qauyihaiyit Maligait*, Maligangit Kaanatami 2013, titiraqhimangani 14, ilanga 2 (*NuPPAA*). Aajjikkutaliuqhimayukkkut titiraakkut, NIRB-kut ilauquiyut ilaayumayunut katimaqatigiingnik, inungnik, aulapkaaiyillu atannguyait ataniqtuqtuiyut taapkuninnga Hanningayumi Havaaghanik uqauhirnik tuhaqtittiyaamik unniutjiyaamiklu Katimayinik ihumagiplugit hapkua:

- a) Tughirautauyut ihuaqhaitjutighat aallannguqtiriyariaqarumi hivulliqnut havaaghanut hivuani qauyihaqhimayutut ihuaqhaitjutighat angiqtauplunilu NIRB-kunnit;
- b) Taapkua tughirautauyut ihuaqhaitjutighat maliguarumik uqauhirnik maliktaghaniklu taja Havaaghanut Titiraaqtanik Nappa 007, taimaaluuniit aallannguqtiriyughaupata Havaaghanut Titiraaqtanik ilittuqhitiyaamik aallannguqtiriyunik; taimaalu
- c) Hunakiaq aghuurnaqtut uqauhilingnut katimayinut ilaayut Katimayit havauhiinut havaaghanut tughirautinut.
