On April 30, 2020 the Nunavut Impact Review Board (NIRB or Board) received TMAC Resources Inc.'s (TMAC) *Hope Bay Project 2019 Nunavut Impact Review Board Annual Report (2019 Annual Report)* as required by the amended Doris North Project Certificate No. 003 and the Phase 2 Hope Bay Belt Project Certificate No. 009.
