RE: NPC File # 149432 [Port Settlement Fog and Air Quality Study in Iqaluit]

The following works and activities have been proposed in the above-noted project proposal:

1. Scientific research to study the chemistry of the atmosphere in Iqaluit. The study will use 12 sampling equipment of size 2'x3' to measure atmospheric gases (O3, NO, NO2, HCl, volatile organic compounds) at the existing Iqaluit meteorological supersite by the Iqaluit Airport. A total of 8 people will be involved in the setup of the equipment in the first week but only 4 will remain for the entire study.
2. Location: Qikiqtani Region [Iqaluit]

The Nunavut Planning Commission (NPC) has determined that this project proposal is outside the area of an applicable regional land use plan.
