Re: <u>Logistics Information and Revised Draft Agenda for the NIRB Community</u>
Roundtable and Pre-hearing Conference for Agnico Eagle's "Saline Effluent
Discharge to Marine Environment" Project Proposal

### Dear Parties:

On December 10, 2020, the Nunavut Impact Review Board (NIRB or Board) provided notification that the Community Roundtable and Pre-hearing Conference as part of the Board's assessment of Agnico Eagle Mines Limited's (Agnico Eagle) "Saline Effluent Discharge to Marine Environment" Project Proposal (the Proposal), which was postponed due to COVID-19 public health restrictions, would be rescheduled for February 11 to 13, 2021. Therefore, the *Draft* Agenda for the Community Roundtable and Pre-hearing Conference, as originally distributed on November 3, 2020, has been revised and included for parties' review (**Appendix A**).

The following correspondence also provides logistical information related to the upcoming inperson Community Roundtable and Pre-hearing Conference and a copy of the NIRB's COVID-19 public meeting protocols (English and Inuktitut) are attached to ensure that participants are aware of the public health procedures in Rankin Inlet.

### ADDITIONAL HUB LOCATIONS

The Community Roundtable and Pre-hearing Conference will consist of in-person meetings in Rankin Inlet. Due to public health restrictions in other parts of Canada, a southern hub is no longer being considered for these proceedings. Intervenors who are unable to attend in Rankin Inlet will be provided with options to participate through a combination of audio and/or video feeds to provide opportunities to support two-way communication for remote attendees. This will include being able to view the audio/video feed of the proceedings online or to access the audio feed by

telephone to allow participation in discussions by phone or via the on-line audio/video feed. The NIRB will be providing additional detail on this matter later in the letter.

The NIRB has applied to the Chief Public Health Officer for an exemption to the 50 person limit for in-person gatherings to allow up to 80 people at Rankin Inlet. An update will be provided upon receipt by the NIRB of the modified order.

### COMMUNITY ROUNDTABLE

The Community Roundtable, hosted on February 11-12, 2021, will provide time for representatives from the five (5) Kivalliq communities within the Qamanirjuaq caribou herd's habitat designated by the Minister of Northern Affairs as potentially impacted by the Proposal to be at the table to discuss the proposal and participate in the NIRB's assessment. Therefore, the NIRB has invited up to three (3) representatives from Baker Lake, Chesterfield Inlet, Rankin Inlet, Arviat, and Whale Cove to attend the Community Roundtable Session and Pre-hearing Conference as nominated by key community organizations. Members of the public from Rankin Inlet are also invited to participate by attending the in-person sessions, and spaces have been reserved per session, and in compliance with public health orders.

All in-person meetings will be managed in accordance with the NIRB's protocol for holding meetings as laid out in respect of personal distancing requirements, accommodations made for personal protective equipment, conducting proceedings to balance attendance with facility occupancy rates, and in compliance with public health orders in place for each location.

### COMMUNITY ORIENTATION TRAINING SESSION

An orientation session will be held for community representatives on **Wednesday**, **February 10**, **2021** (**6:30 p.m. CT**) to demonstrate how proceedings will be conducted and to prepare for the Community Roundtable meeting.

### PRE-HEARING CONFERENCE

As a reminder to all parties the Pre-hearing Conference, hosted in the afternoon on February 12, 2021, will focus on determining the specific steps and processes required to complete the assessment, including matters such as: determining the timing and format for parties to present their evidence to the Board; timelines for the exchange of documents and information required by parties for the proceedings; finalization of issues to be discussed in the proceedings; and/or other matters as determined by parties.

The Pre-hearing Conference is meant to provide parties with an opportunity to confirm agreement to the list of commitments and identify issues resolved during the Technical Meetings, and those issues which remain outstanding, which the Board will consider when issuing a Pre-hearing Conference Decision and providing direction to the Proponent and parties on what steps are required to schedule a Public Hearing for this assessment.

### UPDATED COMMUNITY ROUNDTABLE AND PRE-HEARING CONFERENCE LOGISTICS

The NIRB has made the following logistical arrangements for the Community Roundtable and Pre-hearing Conference:

Interpretation: Simultaneous English and Inuktitut interpretation will be provided to the

extent practicable.

Seating (in-person meeting only): Seating will be assigned at each location based on the

numbers of parties in each location and requirement to maintain space in Rankin Inlet for public participation. Once the maximum meeting number in Rankin Inlet is reached then no more admissions can occur for that session (a session is the morning, afternoon, and evening time slots for the meetings, separated by breaks longer than a health break). Masks will be required in all in-person sessions and adhering to the NIRB protocols and participants will be required to follow the facility health and safety requirements as well as those for the Territory at the time of the meetings.

Facilitator: The Community Roundtable and Pre-hearing Conference will be

facilitated by the NIRB's Chairperson.

**Materials:** The NIRB will provide access to the digital copy of all materials contained

within the Board's Public Registry for the Meliadine Gold Mine project, including the FEIS Addendum and any additional submissions received up

to date and throughout the assessment process.

**Meeting times:** Meetings start at 9:00 a.m. and run until 5:00 p.m. daily (CT), with an hour

break for lunch and two 15-minute health breaks throughout the day with an evening session running from 6:30 p.m. to 9:00 p.m. Under the new NIRB protocols, refreshments will not be served so participants must bring

their own which should avoid standard allergens.

**Format:** In-person with audio/video feed through a Zoom link and a teleconference

option (details provided to registered participants).

Given the limited gathering sizes allowed under current public health orders, seating must be designated and the NIRB will make efforts to ensure fair and appropriate allocation of seats per registered party. The NIRB expects that registered parties maintain full and on-time attendance for their allocated number of seats, for the duration of the meetings, with respect for the limited capacity of the venue and the importance of maintaining adequate seating for members of the public in Rankin Inlet to attend the Community Roundtable.

Due to the preceding requirements, it is critical that parties confirm the list of in-person attendees representing their organizations as soon as possible to ensure they will have the appropriate number of seats in Rankin Inlet. Additionally, parties are requested to provide a list of representatives that will attend through the Zoom link or teleconference options, including name, position, respective area of expertise or authority, and email. Parties should also indicate which individual will be the key speaker for the Community Roundtable and Pre-hearing Conference and this information is required on or before January 27, 2021.

## PUBLIC ACCESSIBILITY AND MEDIA

In an effort to improve public accessibility and participation, the Board is pleased to advise parties that it will be providing the proceedings to all participants through both an audio/video Zoom link and teleconference. All participants will be able to both listen and speak at the meetings in English and Inuktitut through both the Zoom link and designated teleconference lines; however, their audio will be muted, and their video turned off by the technicians until they are addressed to speak by the NIRB's Chair. Should they wish, parties will also be able to listen in English, Inuktitut, or the floor microphone feed through a designated channel once signed into the Zoom link. If using the teleconference lines, parties will only be able to access the English or Inuktitut feeds, requiring them to choose a language they are comfortable both listening and speaking in. Once dialed into the designated teleconference line for their preferred language, parties will be required to speak in the language of that line to ensure interpretation is possible.

Should parties have the bandwidth capabilities, the Board recommends that they attend the proceedings using the Zoom link, this will provide participants with both audio and video on a single platform. When signing in with the Zoom link, it is imperative that you accurately indicate your name, affiliation, and email address in the sign in box to allow technicians to identify the correct person when they are asked to speak. For Participants who will be actively speaking throughout the proceedings (i.e., Proponent, key speakers, etc.) and will be using the Zoom link to respond to questions, the Board is requesting that you be available for a brief testing session, Wednesday February 10, 2021 at 2:00 PM CST. This will allow our technicians to bring each participant into the meeting and test their audio/video feeds and troubleshoot any issues in advance of the proceedings. Throughout the discussions, the NIRB's Chair will address the designated Organizational lead and it will be their responsibility to indicate the name and location of their representative who will be speaking.

Should participants be unable to use Zoom due to bandwidth limitations, it is recommended that you call in using the teleconference details that will be provided the week of February 8, 2021. For individuals using the teleconference line, you will be responsible to coordinate with your key speaker if you are required to speak, this will allow the technicians to unmute your line allowing you to proceed.

### PRESENTATIONS & COMMUNITY ENGAGEMENT

During the Community Roundtable, Agnico Eagle will be expected to present an overview of the Proposal to community representatives and the public, including a discussion on the project components and design, the associated impact assessment findings, and outline its response to community concerns raised to date. The presentation(s) should be organized by project component and include findings of the assessment and issues identified/resolved to date for each component. Agnico Eagle is encouraged to have tools and resources available to assist in their responses to themes, especially to help community members visualize the components and project management activities which may be used during the discussions and ensure that the NIRB is provided copies prior to the beginning of the community roundtable.

Agnico Eagle must notify the NIRB as soon as possible if any of the materials they wish to present are larger than 10MB as methods to transfer the data will have to be considered. Agnico Eagle will also be required to supply print copies of its Community Roundtable presentation in sufficient

numbers for the community representatives and public in Rankin Inlet, with translations in Inuktitut (approximately 40 copies in each language). Digital copies of the presentations must be provided to the NIRB by February 3, 2021 to ensure that all parties can have access via the NIRB's online Public Registry in advance of the meetings.

Responsible Authorities will not be formally presenting at the Community Roundtable but should be prepared to speak to several important topics such as their role in the assessment, information on their interventions, and generally be prepared to respond to questions from community representatives and the public regarding the technical assessment of the Proposal. If Agnico Eagle or parties are asked to provide background on the original Meliadine project and project activities not included within the scope of this assessment, the NIRB asks everyone to please keep responses short and direct.

### MEDIA ACCESS

The NIRB is supportive of any planned efforts by public media outlets to cover or record the Community Roundtable and Pre-hearing Conference and will ensure that media representatives are granted sufficient access to the proceedings to report accurately, while maintaining adherence to public health orders. The NIRB has established rules for recording of Pre-hearing Conference and other proceedings, and due to the COVID-19 protocols will require all media outlets that wish to observe, to provide the NIRB with advanced notice to assist in minimizing disruptions and plan for options should they wish to make either an audio or video recording. As such, the NIRB requests that all media outlets that wish to record proceedings during the Community Roundtable and Pre-hearing Conference (film, photograph, audio) request media access from the Board on or before January 27, 2021.

## **NEXT STEPS**

In summary, parties planning to participate in the upcoming meetings for the NIRB's assessment of Agnico Eagle's "Saline Effluent Discharge to Marine Environment" Project Proposal are required to provide the NIRB with the following information by **January 27, 2021:** 

- Comments regarding the revised draft Community Roundtable and Pre-hearing Conference agenda (Appendix A);
- List of representatives that wish to attend the sessions, including: name, position and respective area of expertise or authority, email, phone number and location participating from, and which sessions they expect to participate in. Parties should also indicate which individual will be the key speaker for the Community Roundtable and Pre-hearing Conference.
- Any requests for specialized audio/visual equipment and/or specific logistical arrangements that may be required during the proceedings;
- Any request by public media outlets to cover the proceedings; and
- Any requirement for French interpretation for the Community Roundtable or Pre-hearing Conference.
